



Existing T-Mobile Coverage




PH35360B (Roadrunner School) Coverage Analysis with Neighbors




PH35360C (ATC Tower) Coverage Analysis with Neighbors






Existing T-Mobile Coverage








PH35360C (ATC Tower) Coverage Analysis with Neighbors

BTS SITE AGREEMENT FOR ECO-SITE TELECOM SITES

This BTS Site Agreement ("BTSSA") is between Eco-Site, Inc., a Delaware corporation, hereinafter designated as CONTRACTOR and T-Mobile West LLC, a Delaware limited liability company hereinafter designated as CARRIER. The effective date of this BTSSA shall be the latest date this BTSSA is executed by an authorized representative of each Party ("BTSSA Effective Date").

This BTSSA is a BTSSA as referenced in that certain BUILD TO SUIT MASTER SERVICES AGREEMENT between T-Mobile USA, Inc. and Eco-Site, Inc. effective December 16, 2013 as amended by the First Amendment to Master License Agreement and First Amendment to Build to Suit Master Services Agreement dated September 22, 2015 ("First Amendment"), Restated Second Amendment to Master License Agreement and Restated Second Amendment to Build to Suit Master Services Agreement dated October 26, 2015 and Third Amendment to Master License Agreement and Third Amendment to Build to Suit Master Services Agreement dated October 26, 2015 and Third Amendment to Master License Agreement and Third Amendment to Build to Suit Master Services Agreement dated April 11, 2016 (collectively, the "BTS Master Services Agreement"). 2. <u>Search Ring Requests</u>. For Search Ring Requests, the Parties will utilize the forms contained in Attachments 1 through 3 of the BTS Master Services Agreement, as amended, to list Candidate Sites, select the BTS Site, set the Milestone Schedule, RAD Center, and ground space for Premises for the BTS Site that is the subject of this BTSSA and to indicate Construction Completion, as set forth in the BTS Master Services Agreement. When completed and signed by the Parties, as set forth in the BTS Master Services Agreement, as amended, the forms will become Attachments 1 through 3 to this BTSSA and are incorporated herein by this reference for all purposes.

3. Sites Where Carrier Has Obtained a Ground Lease. For Sites where Carrier has a Ground Lease and the Parties have not executed a BTS Option Agreement for the Site, the Parties will utilize the forms contained in Attachments 2 through 5 of the BTS Master Services Agreement, as amended, to convey proposed site information, select the BTS Site, set the Milestone Schedule, License Fee, RAD Center, and ground space for Premises for the BTS Site that is the subject of this BTSSA, assign the Ground Lease to Contractor, and to indicate Construction Completion, as set forth in the BTS Master Services Agreement. When completed and signed by the Parties, as set forth in the BTS Master Services Agreement, as amended, the forms will become Attachments 2 through 5 to this BTSSA and are incorporated herein by this reference for all purposes. For sites where Carrier has a Ground Lease and the Parties have executed a BTS Option Agreement for the Site, the Parties will utilize the forms contained in Attachments 2 and 3 of the BTS Master Services Agreement, as amended, to set the Milestone Schedule and to indicate Construction Completion, as set forth in the BTS Master Services Agreement. When completed and signed by the Parties (as applicable), as set forth in the BTS Master Services Agreement, as amended, the forms will become Attachments 2 and 3 to this BTSSA and are incorporated herein by this reference for all purposes.

4. <u>Reservation of Space</u>. Contractor will, at all times, reserve space and the corollary Tower loading for Carrier's Facilities in accordance with the Construction Plans on the Tower at the RAD Center designated in the Site Designation Form (Attachment 2) and on the ground at the BTS Site, all in accordance with Carrier's Maximum Load.

5. <u>Approval of Site; Waiver of MLA Application Process and Fees</u>. The Parties acknowledge and agree that the site application process set out in the MLA, as amended by the First Amendment and any fees normally charged to Carrier as part of the application process shall not apply and are hereby waived. Accordingly, the Parties acknowledge and agree that Contractor's execution of this BTSSA signifies Contractor's acceptance of the Site for purposes of the MLA, as amended.

6. <u>Payment of Carrier's Costs in Event of Assignment and Assumption Agreement for the BTS Site</u>:

a. Contractor will reimburse Carrier for Carrier's Costs in the amount of _______(\$_____) as follows:

Option A \Box Contractor will pay Carrier for Carrier's Costs, as set forth in this Paragraph 6, within thirty (30) Days of the date the Parties mutually execute the Assignment and Assumption Agreement for the BTS Site.

Option B I Contractor will pay Carrier for Carrier's Costs as set forth in this Paragraph 6 at the time(s) specified below:

In the event there is no Assignment and Assumption Agreement, Contractor will pay to Carrier the Carrier's Cost Reimbursement within thirty (30) days of the date the Parties mutually execute the Site License Agreement, in the amount as described in the Site Closeout Form (Exhibit 5 of the First Amendment), where Carrier's Cost Reimbursement means Carrier's actual cost of all Work, if any, performed by Carrier prior to the date the Parties mutually execute the applicable BTSSA. If Carrier has not incurred any development costs prior to the date the Parties mutually execute the applicable BTSSA, no Carrier Cost Reimbursement by Contractor will be due.

- b. If the amount to be paid to Carrier by Contractor for Carrier's Costs is not filled in the space provided for in Paragraph 6(a) above, Contractor will reimburse Carrier for Carrier's Costs as such costs are defined in the BTS Master Services Agreement and invoiced by Carrier. If neither Option A nor Option B is selected in Paragraph 6(a) above, Option B shall be deemed selected. If the Parties select Option B above, but the Parties fail to include language specifying the timing of payment of Carrier's Costs, or the language in Option B specifying the timing of payment is ambiguous, the Parties will be deemed to have selected Option A.
