**Title:** Temporary Road Closure Resolution

### **Introduction/Background:**

USA Cycling has requested the temporary closure of portions of Pistol Hill Road from Colossal Cave Road to Old Spanish Trail for the Colossal Cave Road Race on Sunday, March 12, 2017 from 6:00 A.M. to 4:00 P.M.

### **Discussion:**

As a result of the Pima County Traffic Engineering Division's traffic control plan review, road closures, including potential detour route, if needed due to inclement weather or other circumstances are recommended to facilitate the event.

### **Conclusion:**

Pima County Traffic Engineering recommends the temporary closure of portions of Pistol Hill Road from Colossal Cave Road to Old Spanish Trail to enhance the safety of the Colossal Cave Road Race by reducing potential vehicular conflicts.

### **Recommendation:**

Staff recommends approval of this resolution to temporarily close portions of Pistol Hill Road from Colossal Cave Road to Old Spanish Trail for the Colossal Cave Road Race on March 12, 2017 from 6:00 A.M. to 4:00 P.M.


