Title: Pima County Community Services Request for Proposal (RFP) Process for the Period Beginning May 1, 2017 for the Allocation of Pima County General Funds.

Introduction/Background:

CSET requested proposals (RFP-CSET-YSY-2016-02) from private for-profit business entities, private non-profit corporations, public entities and individuals who have not been debarred or suspended to provide workforce services for the Youth Services -- Summer Youth Activities.

Discussion:

The purpose of this RFP was to select proposers that can help low-income Pima County residents with work experience and applied learning to youth, and basic education/English-as-a-Second Language (ESL)/tutoring to youth and adults. There will be at least two or three rural projects as well as urban projects. The use of Contractors allows the ARIZONA@WORK to provide better outreach to neighborhoods.

Conclusion:

A Review Committee selected the Awardees by an evaluation criteria that included Experience/Credentials, Understanding Employer Needs, Methodology and Cost.

Recommendation:

It is recommended that the Board of Supervisors approve the attached list of selected organizations, appropriate funding in the total amount \$877,275.35 to fund the CSET Youth Services -- Summer Youth Activities, and authorize the Chair of the Board to sign funding contracts with each of the organizations listed.
