**RESTATED ARTICLES OF INCORPORATION
OF
THE PACIFIC SOUTHWEST DISTRICT OF THE WESLEYAN CHURCH**

The undersigned certify that:

1. They are the president and the secretary, respectively, of THE PACIFIC SOUTHWEST DISTRICT OF THE WESLEYAN CHURCH.
2. The Articles of Incorporation of this corporation are amended and restated to read as follows:

**"ARTICLES OF INCORPORATION
OF
THE PACIFIC SOUTHWEST DISTRICT OF THE WESLEYAN CHURCH**

I

The name of this corporation is THE PACIFIC SOUTHWEST DISTRICT OF THE WESLEYAN CHURCH.

II

- A. The corporation is a religious corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation Law exclusively for religious purposes. The corporation elects to be governed by the new Nonprofit Corporation Law as set forth in California Corporations Code Section 9110 to 9690.
- B. The specific purposes of this corporation are to organize, operate, and promote churches and related religious and charitable activities of the faith of The Wesleyan Church. The specific areas of operation of the corporation shall be the states of Arizona, California, Hawaii, Nevada, New Mexico and Utah.

- C. The further general purposes and powers of the corporation shall be to acquire, purchase, manage, sell, exchange, mortgage, deed in trust, pledge, rent, lease, and convey any property, real, personal, or mixed, as may be necessary or convenient for the purposes of the corporation; provided that all such property shall be held in trust, in the corporate name, for the benefit and use of the members and ministers of The Wesleyan Church; to acquire or erect and maintain buildings for the worship of God, the use and occupancy of ministers, Christian education and other activities that are in harmony with the doctrines and ecclesiastical purposes of The Wesleyan Church; to receive and hold in trust for the benefit and use of the members and ministers of The Wesleyan Church any and all donations, bequests, and devises of any kind or character, real, personal or mixed, and that may be given, devised, bequeathed or conveyed to the said corporation district, or to the district board of trustees as such, for any purpose consistent with the ecclesiastical purposes of the corporation, and to administer the same in accordance with the directions of the donor, trustor, or testator; and in addition to have all other powers as are expressly or impliedly given to said corporation by the laws under which it is incorporated when such do not contravene the ecclesiastical provisions of The Discipline of The Wesleyan Church.
- D. This corporation shall propagate and follow the religious faith and doctrine the same as propounded by The Wesleyan Church. The Bylaws shall be adopted that are consistent with the ecclesiastical provisions of The Discipline of The Wesleyan Church.
- E. The term for which the corporation is to exist is perpetual.
- F. The board of directors shall be authorized and empowered to institute all necessary legal and equitable actions in the name of this corporation to protect the interests and rights of The Wesleyan Church within the bounds of the district, including all matters relating to property and the rights to property, whether arising by gift, devise or otherwise, for all property held by this district corporation and all property held by local churches, circuits or other agencies within the bounds of this district which comprise the states of Arizona, California, Hawaii, Nevada, New Mexico, and Utah.
- G. The members of the corporation shall be the members of the district conference as constituted and organized provided that all voting members of the corporation shall be members or ministers of The Wesleyan Church.
- H. The Pacific Southwest District of The Wesleyan Church is the Surviving Corporation of a merger between the California District of The Wesleyan Church, and the Arizona District of The Wesleyan Church, Inc. The merger was preceded in 1968 by the merger of The Pilgrim Holiness Church and The Wesleyan Methodist Church to form The Wesleyan Church.

III

- A. This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.
- B. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

IV

The property of this corporation is irrevocably dedicated to religious purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.

In the event the corporation shall be dissolved, or become inactive, or whenever the board of directors shall cease to function, any and all assets of the corporation remaining after payment, or provision for payment of, all debts and liabilities of this corporation shall be distributed to The Wesleyan Church Corporation if then qualified for exemption from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 as now in effect or as subsequently amended and is organized and operated exclusively for religious purposes, or if not, then to a corporation or corporations, fund or funds, or foundation or foundations, so qualified for such exemption as above stated, and the General Board of Administration in the name of The Wesleyan Church Corporation shall carry on the functions of the corporation and exercise its corporate powers and shall be authorized to institute any necessary legal or equitable actions to preserve the interests and rights of the district and of The Wesleyan Church."

- 3. The foregoing amendment and restatement of Articles of Incorporation has been duly approved by the board of directors.
- 4. The foregoing amendment and restatement of Articles of Incorporation has been duly approved by the required vote of members.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.

Section IV - District Boards and Committees

A. The District Board of Administration

1. The District Board of Administration shall be composed of 16 members: the four ex-officio members (district superintendent, assistant district superintendent, district secretary, district treasurer), up to two additional assistant district superintendents and members at large- six ministers (reduced if there is more than one assistant district superintendent) and six laity. The district superintendent and secretary are elected by the conference by ballot with the nominating committee presenting nominations for the secretary. The assistant district superintendents are elected by the DBA after a nomination by the district superintendent. The treasurer is appointed by the district board of administration. The Nominating Committee shall nominate at least 14 persons for ministerial members at large and at least 14 persons for lay members at large for the District Board of Administration.
2. The board shall meet in at least five regular sessions; special sessions may be called by the executive committee or the district superintendent.
3. An executive committee composed of the four ex-officio members of the DBA and four other members elected by the DBA (two ministers, two laymen) shall meet at regular intervals or at the call of the district superintendent and shall be authorized to perform all functions of the board between sessions with these exceptions:
 - a. May not set official policy
 - b. May not set policy for purchase or sale of property (but is authorized to buy and sell within the limits of established policy)
 - c. May not recommend directly to district conference
 - d. May not elect officers and committees (except in emergencies)
 - e. May not fill vacancies (except in emergencies)
 - f. May not remove anyone from office
4. At each session of the DBA, an opportunity shall be given to have pastors and local church representatives present suggestions and recommendations to the board.
5. The District Board of Administration is the board of trustees of the corporation--The Pacific Southwest District of The Wesleyan Church. The district superintendent is the corporation president; the assistant district superintendent is the corporation vice-president; the district secretary is the corporation secretary; the treasurer is the corporation assistant secretary and treasurer. The president (or vice-president) and the secretary (or assistant secretary) are authorized to sign all legal documents for the corporation.
6. The minutes of each meeting of the District Board of Administration and the district treasurer's report shall be supplied to all board members, to the pastors, and to all full-time associate and assistant pastors of each local church. A report in summary form shall be made to the district conference. News releases shall be placed in the district newsletter.

B. Church Property

1. Ownership

4680. Local property within an established district may be held by the local church or by the district, as decided upon by the district conference (cf. 1180:21–22). In those districts where the local churches are to hold their own property, all grants, conveyances, devises, gifts, transfers, and assignments now owned or hereafter acquired of any property, real, personal or mixed, to or for any unincorporated local church or any organization, board or similar body connected thereto, shall be held by and/or conveyed to its duly elected board of trustees, and to their successors in office and their assigns, as the board of trustees of such local church, in trust for the benefit and use of the members and ministers of The Wesleyan Church, subject to its *Discipline*, regulations and appointments as from time to time legislated and declared and shall contain the appropriate trust clause as set forth in 4610 (cf. 4590; 4620). An omission of the name of any or all of the trustees shall not render any instrument invalid. (The regulations for an incorporated local church are set forth in 4000–4070.) In those districts where the district is to hold local property (cf. 323:8), such local property shall be held as set forth in 4140 or 4830.

2. Trust Clause and Release Therefrom

4690. All written instruments of conveyance by which property is held or hereafter acquired by any local church, whether incorporated or unincorporated, shall contain the trust clause in 4610, and release therefrom shall be as follows:

(1) Whenever the real property of a local church acquired by a conveyance containing the trust clause as set forth in 4610 is sold in conformity with the provisions of *The Discipline* (4700–4720), the written approval of the district board of administration (4700:3) shall constitute a release and discharge of the real property so sold and conveyed from the trust clause (cf. 4620).

(2) Whenever the real property of a local church, acquired by a conveyance containing the trust clause in 4610, is mortgaged or encumbered as provided for in *The Discipline* (4700–4720), the written approval of the district board of administration for such mortgage or encumbrance (4700:3) shall constitute a formal recognition of the priority of such mortgage lien and the subordination of the trust clause thereto (cf. 4630).

3. Acquisition, Sale, Mortgage and Transfer of Property

4700. An unincorporated local church within an established district may acquire, purchase, sell, mortgage, transfer or otherwise dispose of real property in accord with the following authorization and conditions:

(1) A resolution authorizing such action shall be recommended by the local board of administration (782:32), and passed by the local church conference (655:13) by a majority of those present and voting, at any regular or special session duly called for such purpose, provided that notice of the intended action shall be given to the local church members by announcement from the pulpit in two regular services, the first of which shall be not less than one week before the date of the session of the local church conference at which the proposal shall be considered, and that notice shall also be given at least one week in advance in the church bulletin, when such is available, and that such other notice shall be given as may be required by local laws (cf. 633:1).

(2) The proposal shall be studied by the district building committee whenever it involves the purchase of property, the construction or remodeling of buildings or other work as set forth in 1345, and the written recommendation of the district building committee shall be forwarded to the district board of administration and the local church.

(3) The district board of administration, after receiving the recommendation of the district building committee, shall approve the proposal of the local church in writing and such approval shall be affixed to the written instrument involved (1233:33).

(4) The resolution authorizing such action shall direct that any contract, deed, bill of sale, mortgage or other necessary written instrument be executed by and on behalf of the local church by the proper officers of the local board of trustees, who thereupon shall be duly authorized to carry out the directions of the local church conference and the local board of administration in keeping with the requirements of *The Discipline* (cf. 850-859; 4500-4630; 4720); and any written instrument so executed shall be binding and effective as the action of the local church.

(5) The chair of the local board of trustees, or other designated trustee, shall submit all written instruments of conveyance and title for the acquisition of property to the district superintendent for approval as to their conformity with *The Discipline* as stated in 1310:13 and shall see that permanent legal and property records are properly stored as set forth in 4760.

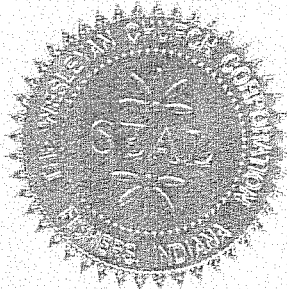




