Construction Manager At Risk Services For Old Nogales Interceptor / Aerospace Corridor / Park Avenue Sewer Augmentation - Project 3ASC15

### **Purpose:**

Amendment of Award: Contract No. CT-WW-16-208, Amendment No. One (1). This amendment increases the award amount from \$576,735.21 to \$1,901,946.40 and incorporates Guaranteed Maximum Price No 1 (GMP-1).

GMP-1 pertains to project Phase 3 and provides for coordination of community relations prior to and during construction and for all construction activities for this phase. Due to limited subcontracting opportunities, no Small Business Enterprise (SBE) goal is established for GMP-1.

Administering Department: Regional Wastewater Reclamation.

#### **Procurement Method:**

Pursuant to Solicitation For Qualifications No. 187502, the Board of Supervisors awarded a contract for this project on February 16, 2016 in the amount of \$576,735.21 for preconstruction services for a contract term of February 16, 2016 to July 31, 2020.

### CONSTRUCTION CONTRACT AMENDMENT

WHEREAS, COUNTY and CONTRACTOR have entered into the Contract for the project referenced above; and

WHEREAS, construction of the project was anticipated to be conducted in multiple phases; and

WHEREAS, construction of project Phase 3 shall be conducted first while design of Phase 1 and Phase 2 continues; and

WHEREAS, GMP-1 shall pertain to project Phase 3; and

WHEREAS, COUNTY and CONTRACTOR, pursuant to Article 2, have agreed to incorporate Guaranteed Maximum Price-1 (GMP-1) into the contract for all Phase 3 activities, including coordination of community relations prior to and during construction and for all construction activities; and,

**WHEREAS**, COUNTY's acceptance of GMP-1 is subject to the understanding of the Parties that all other elements of future GMPs, if any, are and remain negotiable; and,

WHEREAS, COUNTY and CONTRACTOR pursuant to Article 3 have agreed to increase the Contract amount as identified in GMP-1.

NOW, THEREFORE, it is agreed as follows:

### CHANGE: ARTICLE III - PRECONSTRUCTION PHASE FEE AND GUARANTEED MAXIMUM PRICE

#### Insert after Paragraph B:

Guaranteed Maximum Price-1 (GMP–1) for all construction activities and coordination of community relations prior to the commencement of construction and during construction as identified in APPENDIX "C" is One Million, Three Hundred Twenty-Five Thousand, Two Hundred Eleven Dollars and Nineteen Cents (\$1,325,211.19). COUNTY reserves the right to negotiate the construction fee, overhead rate, and all other elements of future GMPs, if any.

# **ATTACHMENT #3 - CLARIFICATIONS, ASSUMPTIONS, EXCLUSIONS**

GMP#1 - CONSTRUCTION OF PHASE 3 SEWER (Drexel Road: 1st Ave to Park Ave) Updated: March 30, 2017

	CLARIFICATIONS, ASSUMPTIONS, AND EXCLUSIONS TO THE SCOPE OF WORK:
1	GMP was established with the understanding that the Phase 3 project needs to be started and completed between June and August of 2017, while Drexel Elementary School is on summer break. As such, extended work hours and weekend work have been accounted for to meet the aggressive construction schedule. It is assumed RWRD/COT inspectors and other jurisdictional authorities will implement similar scheduling to complete the project on schedule.
2	Railroad flagger and insurance have been removed from this GMP as project limits are now entirely outside (east of) UPRR's right-of-way.
3	3 weeks of flow management costs are accounted for in the GMP. This includes one week for construction and two weeks for RWRD/DEQ authorization.
4	No flow management cost is included for the construction of new manholes over the existing 8" lines in Morris and Southland. New manholes are to be poured around existing live sewer. GMP includes an allowance should upstream manholes need to be plugged and pumped with vactor.
5	GMP is based on using native material for backfill of all sewer trenches, HCS, manholes, and sewer removals - including within the roadway limits of Drexel Road/Park Avenue. The acceptance of native backfill is based on discussions with COT and RWRD during design phase.
6	Slurry backfill was included for backfill of sewer bypass trenches only (Park Ave/Drexel Rd intersection). All other trench backfill to be native material (see clarification #5).
7	Included in the GMP is an allowance for removing and replacing asphalt and ABC over the existing reclaimed water line in Drexel Road (which appears to have experienced trench settlement causing asphalt failure and cracking). This allowance is for a new 2" asphalt base course and replacement of 4" ABC (per the existing pavement section) - it does NOT include reconstruction of the existing subgrade.
8	GMP includes an allowance to re-grout/repair manhole 1751-10.
9	SWPPP to be provided by Westland - Installation of BMP's included in this GMP
_10	GMP does not include cultural resources / archaeological monitoring.
11	Bypass includes tarping the discharge for odor control - any additional/separate odor control mitigation is NOT included in our GMP
12	Cost for flow management of existing ONH, MH 1751-10, includes the use of flow through plug /invert protection, per conversations with RWRD during design phase.
13	GMP does not include any bio filter costs.
14	New HCS unit prices do NOT include the installation of cleanouts at the property line. Connections to existing HCS lines will occur within the asphalt limits of Drexel Road - no cost have been included for other right-of-way improvements/disturbances. It was assumed that existing HCS pipe is in good condition and able to be attached to. Existing and new HCS lines to be coupled together using a fernco adapter.

	weekends / nights due to expedited construction schedule.
16	Mill and replacement of Drexel Rd asphalt is assumed to be curbline-to-curbline (approximately 48' in width), from the east curbline of 1st Ave to 50' east of Park Ave. Also included is the curb return areas at the intersections of Southland Blvd and Morris Blvd (See GMP Attachment #7). Other driveways, school bus pullouts, sidestreets, and paved shoulders are specifically excluded from the milling area for Phase 3. Milling depth is to be 2" thick and roadway will be repaved using TDOT #2 mix. No recompaction/reconstruction of subgrade, crack sealing of existing pavement, or any other structural section stabilization is included in this GMP. Existing cracking and/or other subgrade deficiencies will reflect through new 2" asphalt over time.
17	GMP excludes any cost associated with discovery of concrete encasement and required removal for installation of new utilities.
18	GMP excludes the relocation of existing utilities - with the exception of the existing 12" water line at southwest quadrant of Park/Drexel.
19	Traffic control is an allowance item and will be billed based on actual vendor invoice plus applicable markups.
20	No hazardous materials removal/handling cost are included in this GMP
21	Production rates, unit costs, and schedule durations included in this GMP are based on a 24-hour closure of Drexel Road (no through traffic) for the duration of the project (local access and emergency services will be maintained during closure).
22	Production rates, unit costs, and schedule durations included in this GMP are based on (2) separate weekend closures of the Park Ave/Drexel Road intersection. Closure to begin on Friday at 9pm and end on Monday at 6am.
23	Temporary paint striping to be placed upon completion of overlay and final thermoplastic striping to be placed 30 days later.
24	This GMP does not include any SBE utilization based on conversations with Pima County SBE Department.
25	GMP does not include any RWRD 2.5% inspection fees.
26	No cost are included for bypass of existing HCS's lines or accommodation with portable restrooms. Coordination with home owner will be made during connections.
27	GMP does not include costs related to Construction Authorization and Discharge Authorization applications/fees
28	Due to the critical construction schedule and completion deadline, deflection testing (and/or any other inspection/testing) will need to be performed immediately after installation. The schedule does not allow for the 7-day wait called out in the RWRD spec page 3-26 item D. Should the county need us to retest the line at a later time we will be glad to do so.


