Title: Resolution Authorizing Pima County to Condemn for La Cholla Boulevard: Overton Road to Tangerine Road Project Code: 4LCBOT File: Pr-0035

Introduction/Background:

Pima County needs to acquire right of way and real property rights for the La Cholla Boulevard: Overton Road to Tangerine Road improvements (the "Project").

Discussion:

In the event the real property interests for the Project cannot be acquired through timely negotiations, Pima County may have to exercise its powers of eminent domain to acquire the necessary interests to construction the Project.

Conclusion:

The Pima County Attorney will be authorized to institute condemnation proceedings to acquire real property interests for the Project.

Recommendation:

Staff recommends that the Pima County Board of Supervisors approve the Resolution authorizing the Pima County Attorney to condemn real property interests, when necessary, for the Project.

RESOLUTION OF THE PIMA COUNTY BOARD OF SUPERVISORS AUTHORIZING THE PIMA COUNTY ATTORNEY TO CONDEMN REAL PROPERTY INTERESTS WHERE NECESSARY FOR <u>LA</u> <u>CHOLLA BOULEVARD: OVERTON ROAD TO TANGERINE ROAD</u> IN SECTIONS <u>3</u>, 4, 9, 10, 15, 16, 21, & 22 OF TOWNSHIP <u>12</u> SOUTH, RANGE <u>13</u> EAST, G&SRM, PIMA COUNTY, ARIZONA

The Board of Supervisors of Pima County, Arizona finds:

- 1. Pima County plans to make road improvements to 3.3 miles of La Cholla Boulevard; Overton Road to Tangerine Road (the "Project") located in Sections <u>3</u>, <u>4</u>, <u>9</u>, <u>10</u>, <u>15</u>, <u>16</u>, <u>21</u>, <u>& 22</u> of Township <u>12</u> South, Range <u>13</u> East, G&SRM, for the use and benefit of the public; and
- 2. The Board of Supervisors of Pima County finds it is necessary to exercise its powers of eminent domain, pursuant to A.R.S. § 12-1111, to acquire interests in the real property depicted in attached **Exhibit A** in order to construct the Project;

NOW, THEREFORE, BE IT RESOLVED that the Pima County Attorney be and is hereby authorized and directed to institute condemnation proceedings to acquire real property interests for the above described Project, from the real property shown on the attached **Exhibit A**.




