Resolution Authorizing Pima County to Condemn for the Broadway Sewer Augmentation: Chantilly Drive to Title: Craycroft Road Project

Introduction/Background:

Pima County plans to construct sewer improvements for the Broadway Sewer Augmentation: Chantilly Drive to Craycroft Road Project (the "Project") and requires certain interests in real property for the Project.

Discussion:

In the event the real property interests for the Project cannot be acquired through timely negotiations, Pima County may have to exercise its powers of eminent domain to acquire the necessary interests to construct the Project.

Conclusion:

The Pima County Attorney will be authorized to institute condemnation proceedings to acquire real property interests where necessary for the Project.

Staff recommends that the Pima County Board of Supervisors approve the Resolution authorizing the Pima County Attorney to condemn real property interests when necessary for the Project.

The Board of Supervisors of Pima County, Arizona finds:


- 1. Pima County plans to construct the Broadway Sewer Augmentation Project: Chantilly Drive to Craycroft Road Project (the "Project") to accommodate future residential and commercial growth along Broadway Boulevard. The new public sewer alignment will increase the sewer main capacity. The Project is located in Section 12 of Township 14 South, Range 14 East, G&SRM, Pima County, Arizona; and
- 2. The Board of Supervisors of Pima County finds it is necessary to exercise its powers of eminent domain, pursuant to A.R.S. §12-1111, to acquire interests in the real property depicted on the attached **Exhibit A** in order to construct the Project;

NOW, THEREFORE, BE IT RESOLVED that the Pima County Attorney be and is hereby authorized to institute condemnation proceedings to acquire real property interests necessary for the above described Project, from the real property shown on the attached **Exhibit A**.


