#### **Project Title/Description:**

Workforce Assistance for the Homeless. The Pima County Sullivan Jackson Employment Center network to assist people experiencing homelessness in Pima County become self-sufficient.

#### Purpose:

This amendment allows SER - Jobs for Progress of Southern Arizona, Inc. to continue providing critical activities to homeless youth, veterans, families and individuals as part of the Pima County Sullivan Jackson Employment Center (SJEC) program.

Contractor will continue to provide an outreach function to individuals and families living in washes, cars and other sites by responding to contacts under County Homeless Protocol. As part of the outreach, basic assessment is conducted and a search for shelter is made. Contractor also outreaches to shelters to identify those who are considered to be potentially employable.

Contractor will continue to provide case management and support services to participants engaged in SJEC's program. Support services are in addition to those not normally available through CSET's system such as bicycles and household goods for families and individuals moving into rapid rehousing.

Contractor will continue to provide intense, structured job seeking workshops. Contractor will initiate a new workshop 48 weeks of the year. Each workshop takes two weeks (unless a job is obtained before that). Workshops are 30 hours a week.

## **Program Goals/Predicted Outcomes:**

SER - Jobs for Progress of Southern Arizona, Inc. will ensure that 80% of homeless participants who enter SJEC enroll in employability skills workshops and 50% will find employment and earn at least \$10.50 per hour.

#### **Public Benefit:**

The program provides a path for people experiencing homelessness in Pima County to find and maintain employment and housing.

#### Metrics Available to Measure Performance:

SER - Jobs for Progress of Southern Arizona, Inc. will report monthly numbers of participants who completed the program and average wage of placement.

**Housing Program** 

Pima County, a body politic and corporate of the State of Arizona ("County") and SER-Jobs for Progress of Southern Arizona, Inc., a non-profit corporation registered to do business in the State of Arizona ("Awardee") have entered into the above-referenced contract to provide workforce development services to eligible homeless individuals.

#### AMENDMENT ONE

A. County, as Grantee, receives funds from the United States Department of Housing and Urban Development ("HUD") under the McKinney-Vento Act to provide employment assistance to homeless individuals. County is authorized to pass these funds to subrecipients, including Awardee. The HUD grant ends in 2018.

- B. County, as Subrecipient, receives funds from the Arizona State Social Services Block Grant ("SSBG") for the provision of employment services. County is authorized to pass these funds through to other subrecipients, including Awardee.
- C. County, as Subrecipient, receives ECHO Permanent Supportive Housing Program funds from the City of Tucson and is authorized to pass these funds along to Awardee for the provision of services to the homeless.
- D. The Pima County Board of Supervisors finds that extending this Contract is in the best interests of the residents of Pima County and will improve employment opportunities for the homesless.
- E. County has reviewed Awardee's performance and finds it satisfactory.

NOW, THEREFORE, County and Awardee agree to amend the Contract as follows:

## 1. SECTION 1.0 – TERMS AND EXTENIONS, paragraph 1.1 is amended as follows:

1.1 The termination date is changed:

FROM: June 30, 2017 TO: June 30, 2018

1.2 The number of available renewals is changed:

FROM: four (4) additional years or any portion thereof

TO: three (3) additional years or any portion thereof

## 2. SECTION 3.0 – COMPENSATION AND PAYMENT, is amended as follows:

- 2.1 **Paragraph 3.1** is deleted in its entirety and replaced with the following:
  - 3.1 In consideration for the services specified in **Exhibit A** of this Contract, County agrees to pay Awardee **up to \$994,126.00** ("the Maximum Allocated Amount").
- 2.2 **Paragraph 3.2** is deleted in its entirety and replaced with the following:
  - 3.2 Payment, up to the Maximum Allocated Amount, will be made from federal and state grants County received from various agencies (collectively the federal awarding agency") and Pima County general funds. Funds not expended during a contract year may not be carried over for use in a subsequent contract year. Anticipated expenditures from each source are as follows, but the actual amount of grant funds utilized may vary based on the eligibility of program participants:

Awardee hereby certifies that it is not currently engaged in, and will not for the duration of this Agreement engage in, a boycott of Israel as defined by A.R.S. § 35-393.01. Violation of this certification by Awardee may result in action by County up to and including termination of this Agreement.

  - 1.2 Unless otherwise specified herein, participation in programs and activities financially assisted in whole or in part by this Contract must be open to citizens of the United States, lawfully admitted permanent resident aliens, lawfully admitted refugees and parolees, and other individuals authorized by the U.S. Attorney General to work in the United States.

    - 4.5.1.3. **Paragraph 1.1.**4, subparagraph 1.1.4.1 is amended to increase the number of HOS:

    - 1.1.6.3 Work scheduled hours (personnel may not be assigned to work during hours that the county location is not open for business); and
    - 1.1.6.4 Inform both Awardee and assigned County contact the morning of an absence due to illness or necessary appointments.

# WORK STATEMENT NO. 1 – OUTREACH, CASE MANAGEMENT & GENERAL ADMINISTRATION SERVICES

#### Paragraph 2.2 is replaced with the following:

- 2.2. <u>Homeless Outreach Specialist ("HOS")</u>. Awardee will provide two qualified individuals to provide services as follows:
  - 2.2.1. One (1) HOS (12 months) will:
    - 2.2.1.1. Regularly visit homeless shelters and other areas where the homeless congregate and contact approximately <u>500 homeless youth and adults</u>. With the individuals contacted:
      - 2.2.1.1.1. Administer the Vulnerability Index Service Prioritization and Decision Assistance Tool ("VI-SPDAT").
      - 2.2.1.1.2. Identify the services needed to secure or maintain employment and refer to SJEC for enrollment in appropriate program(s).
      - 2.2.1.1.3. When possible, provide immediate on-site assistance, including, but not limited to:
        - 2.2.1.1.3.1. Bus passes;
        - 2.2.1.1.3.2. Directory of Pima County Homeless Programs; and
        - 2.2.1.1.3.3. Referral to RAPP Team or Crisis Response Center.
    - 2.2.1.2. Maintain contact and working relationships with the faith-based community and the Federal and State Prison Re-Entry Committee to locate homeless and, when possible, refer to SJEC programs.
  - 2.2.2. One HOS (6 months) will provide services under the ECHO program. This HOS will spend a majority of time in the field to locate clients who have been referred to the ECHO program and ranked highest on the Coordinated Entry list (collectively "clients"). In performance of this work, the HOS will:
    - 2.2.2.1. Work with ECHO case managers and attend outreach sessions, case conferencing and ECHO program meetings.
    - 2.2.2.2. Be familiar with sites where homeless congregate or may be located and the resources available for locating homeless individuals.
    - 2.2.2.3. Administer the Service Prioritization and Decision Assistance Tool ("SPDAT") and assist individuals in attaining services.
    - 2.2.2.4. Provide bus passes or transport clients to appointments, if needed.
    - 2.2.2.5. Assist clients in attaining Bridge housing wherever and whenever possible.
    - 2.2.2.6. For maximum impact, visit shelters and other sites on weekends and evenings, when determined appropriate.
    - 2.2.2.7. Act with compassion and respect.
    - 2.2.2.8. Perform other related work, as required.
