Re: **Proposed changes to Pima County Ordinance 6.04.060, Pima Animal Care Center Fees**

We have received a number of requests for information regarding the above referenced fee ordinance and the changes it includes. Staff has provided the attached table to facilitate such a comparison.

Section C provides authority to charge fees to residents from nonparticipating jurisdictions. It is structured to reflect the costs associated with State mandated hold times (three-day holds for unowned pets; five-day holds for owned pets). Residents of nonparticipating jurisdictions who elect to not receive such services from their jurisdiction's agent would be subject to this charge. (Relevant items are shaded in orange on the attached table.)

Staff also took the opportunity to re-examine all Pima Animal Care Center (PACC) fees to ensure they are equitable and based on the true costs of providing services. The fees highlighted in green in the table indicate fees that have not changed or that have been decreased based on our review. The table also highlights in blue new and/or increased fees for services we currently perform or may perform in the future.

The proposed fee revision is critical for County taxpayers. It provides a mechanism for us to attempt to recover fees, especially for animals impoundments associated with protracted legal proceedings. In such cases, these pets may be in our care and custody for many months pending a legal resolution. Additionally, as we approach philanthropic organizations in the animal welfare space, it is essential we have an established fee schedule for the types of services they may wish to support.

PACC strives to serve our community everyday by offering essential services in animal welfare, and we are committed to doing so in a fiscally responsible manner.
