*Project Title/Description:

Continuum of Care Program - One-Stop Rapid Rehousing (RRH). The original contract and other amendment may be found under CT-16*332. Search contract number 16%332 in eContracts.

*Purpose

The Department of Housing and Urban Development (HUD) awarded Pima County \$200,681.00 to provide rapid rehousing and employment services to people experiencing homelessness in order for them to become self-sufficient.

This amendment is to change the term date to 9/15/17 per the request of CODAC Health, Recovery & Wellness.

*Procurement Method:

RFP-CSET-2015-4

*Program Goals/Predicted Outcomes:

The program provides a minimum of 15 units to eligible homeless participants, and rapid rehousing case management and associated services to a minimum of 50 participants (a homeless family is considered one participant).

*Public Benefit:

This program helps reduce the number of people experiencing homelessness in Pima County and provides a path toward employment and self-reliance.

*Metrics Available to Measure Performance:

As a HUD program, metrics are measured through the Homeless Management Information System (HMIS).

*Retroactive:

Yes, amendment needed to be written to reflect language changes and change of term end date. The negative impact of amendment not being approved would be unspent funds would be returned to HUD and less participants would be served.

Pima County, a body politic and corporate of the State of Arizona ("County") and CODAC Health, Recovery & Wellness, Inc., an Arizona non-profit corporation ("Awardee") have entered into the above-referenced Contract to provide supportive services and rental assistance to the homeless in Pima County.

AMENDMENT TWO

- A. The United States Housing and Urban Development ("HUD") provided funding to the Pima County Continuum of Care ("CoC") for services designed to reduce homelessness.
- B. The expenditure deadline for CoC funds has been extended by HUD to October 30, 2017.
- C. The Pima County Board of Supervisors finds that it is in the best interests of the residents of Pima County to continue to provide Rapid Rehousing ("RRH") services for the homeless.
- D. Awardee has expressed interest in providing RRH services pursuant to the terms of the Contract through September 15, 2017.
- E. County has reviewed Awardee's performance and finds it satisfactory and finds that Awardee has the capacity to provide RRH services as set forth below.

NOW, THEREFORE, County and Awardee agree to amend the Contract as follows:
