It was moved by Chair Bronson, seconded by Supervisor Miller and unanimously carried by a 5-0 vote, to approve the item. Supervisor Christy made the presentation.

They offered the following comments:

- Thousands of animals are processed through PACC each year and the Animal Care Advisory Committee takes pride in ensuring that funds are spent efficiently and wisely.
- Volunteers volunteer over 70,000 hours each year and they continue to be watchdogs for the public's interest.
- PACC was a model facility that other states would like to emulate and learn from.
- Cleanliness was not achieved with the contract using inmates and disease control was also an issue.

Keith Van Heyningen addressed the Board regarding Project Curvature, World View, roads, and the appointment of Ray Carroll to JP7.

Gerri Ottoboni addressed the Board regarding overtaxed seniors and the 30-day challenge to find the County's HURF funds.

Christopher Cole, Libertarian Party, addressed the Board regarding property taxes, Tucson being the fifth poorest metropolitan area in America, and acknowledged Veteran's Day.

Russell Trask addressed the Board regarding transparency for RICO spending and supported the half-cent sales tax for road repair.

Paul Parisi, 4Tucson, addressed the Board regarding Election Day and invited the Board to attend 4Tucson's Reception Blessing Breakfast for elected officials and first responders in January.

Paula Hughes addressed the Board protesting the road repair tax on her property tax statement and requested a refund.

Dru Heaton addressed to the Board regarding the invocation agenda item, McDonald v. Napier legal opinion, criminal intelligence analyst job classification and the Jose Guerena case settlement.

Brian Bickel addressed the Board regarding the distribution of Vehicle License Tax (VLT) funds per Arizona statute and compared the distributions for Maricopa County and Pima County.

Bob Dorson addressed to the Board regarding the 35th El Tour de Tucson and urged everyone on the roads to be careful with bicyclists.

6. CONVENE TO EXECUTIVE SESSION

It was moved by Supervisor Valadez, seconded by Chair Bronson and carried by a 4-0 vote, Supervisor Elías was absent, to convene to Executive Session at 10:03 a.m.

7. **RECONVENE**

The meeting reconvened at 10:27 a.m. Supervisor Ellas was absent. All other members were present.

EXECUTIVE SESSION

8. Pursuant to A.R.S. §38-431.03(A) (3) and (4), for legal advice and direction regarding a decision in McDonald v. Napier, et al., 2CA-CV 20160155.

Andrew Flagg, Chief Civil Deputy County Attorney, stated the County Attorney's Office sought direction on whether to file a petition for review with the Arizona Supreme Court on the Court of Appeal's decision.

It was moved by Supervisor Valadez, seconded by Supervisor Christy and carried by a 4-0 vote, Supervisor Elías was absent, to file a petition for review.

9. Pursuant to A.R.S. §38-431.03(A) (3) and (4), for legal advice and direction regarding the propriety of an individual member of the Board of Supervisors contacting a person who is a party to litigation adverse to Pima County or the Pima County Flood Control District.

This item was informational only. No Board action was taken.

10. Pursuant to A.R.S. §38-431.03 (A) (3) and (4), for legal advice and direction regarding a proposed settlement agreement in Eva Jackson, et al. v. Mark Napier, et al., U.S. District Court Case No. 15-CV-00052.

Andrew Flagg, Chief Civil Deputy County Attorney, stated that a proposed settlement of \$400,000.00 to settle both plaintiffs' claims had been reached. The County Attorney's Office sought direction on whether to proceed with the proposed settlement.

It was moved by Supervisor Valadez, seconded by Supervisor Christy and carried by a 4-0 vote, Supervisor Elías was absent, to proceed with the proposed settlement. 11. Pursuant to A.R.S. §38-431.03(A) (3) and (4), for legal advice and direction regarding a Petition for Waiver of Real Property Taxes by the Rialto Theatre Foundation for tax year 2017 for Parcel Nos. 117-06-168C and 117-06-177B under A.R.S. Section 42-1153(B) 42-11153(B).

At the request of staff and without objection, this item was continued to the Board of Supervisors' Meeting of December 12, 2017.

BOARD OF SUPERVISORS

12. Road Repair Plan

Continued discussion of a 3-step countywide road repair plan:

- 1. The repeal/de-authorization of the property tax for road repair;
- 2. Enactment of a one-half-cent Pima County sales tax;
- 3. Pima County sales tax revenue directed to the Regional Transportation Authority for the development, administration, and execution of a countywide RTA Road Repair Program. (District 4)

Supervisor Christy inquired about what protocol would need to be taken in order to repeal the enacted property tax for road repair.

Andrew Flagg, Chief Civil Deputy County Attorney, responded that the road tax was a portion of the primary property tax rate levied by the Board in August 2017. He stated the statutes for budgeting and tax levy did not have a provision by which the Board could repeal portions of the primary property tax rate already levied for the fiscal year. He added that in order to repeal the road tax, with the effect of reducing the primary property tax rate, that process would have to occur as part of the budget cycle for the next fiscal year.

Chair Bronson stated that any de-authorization the Board approved would not be effective until July 1, 2018.

Mr. Flagg responded that that was correct.

Supervisor Christy questioned whether the Board could enact a repeal that would take effect on a certain date.

Mr. Flagg explained the Board could express the intent, but because it was a primary property tax rate, it would need to be done as part of the budget and tax levy process.

Mr. Huckelberry commented about a previous tax rate case in which the County was faced with a one percent constitutional property tax rate imposed by the legislature, the Board adopted an additional rate in the levy to offset that one percent. The County appealed the transfer in court and were successful and the following year the Board was able to rebate the money collected. He indicated that the Board could consider the same action by repealing the property tax and adopting a half-cent sales tax, and refund any property taxes collected.

Supervisor Christy inquired whether it could be repealed prior to the budget process.

Mr. Huckelberry responded that the budget would be predicated on adoption of a half-cent sales tax, and if the budget was predicated on that, then the repeal would be included in the recommended property tax rate. He added that it would be lowered by at least 25 cents, plus the growth offset to lower property taxes.

Supervisor Christy inquired about the status of the property taxes being collected for this fiscal year.

Mr. Huckelberry responded that the taxes collected are being set aside as a separate levy line item in the property tax bill. He indicated that it would be expended as approved by the Board on road repairs for this fiscal year.

Supervisor Christy inquired whether the funds could be frozen from spending.

Mr. Huckelberry responded that the Board would have to provide that direction.

Supervisor Christy questioned whether that direction required a unanimous vote or majority vote.

Mr. Huckelberry stated it would take a majority vote.

Supervisor Christy commented about the ease to enact a tax, and the restrictions that limited the Board from repealing a tax. He encouraged Board members to join in the conversation and work together to find ways to fix the roads.

Supervisor Miller inquired whether monies could be transferred over to the Regional Transportation Authority (RTA) under the existing legislation that authorized the RTA.

Mr. Flagg responded that Supervisor Christy had requested legal opinions from the County Attorney's Office and RTA's counsel with regard to that matter and a response would be provided.

Wendell Long, Sales Tax Advisory Committee, thanked the Board for the committee's creation. He thanked Supervisor Christy for his attendance at the meetings and invited other Board members to attend.

No Board action was taken.

P16RZ00012 TUCSON LINDA-VISTA 20 LTD PARTNERSHIP, ET AL. - N. SHANNON ROAD REZONING

Request of Tucson Linda-Vista 20 Ltd Partnership, et al., represented by The WLB Group, for a rezoning of approximately 78.6 acres from SR (Suburban Ranch) to the CR-2 (CL) (Single Residence - Cluster) zone, Parcel Codes 225-02-001B, 225-02-002E, and 225-04-014G located at the southeast and southwest corners of the Linda Vista Boulevard alignment and Shannon Road. The proposed rezoning conforms to the Pima County Comprehensive Plan Low Intensity Urban 0.3 designation. On motion, the Planning and Zoning Commission voted 5-0 (Commissioners Bain, Cook, Mangold and Matter were absent) to recommend APPROVAL SUBJECT TO STANDARD AND SPECIAL CONDITIONS. Staff APPROVAL STANDARD SUBJECT TO AND SPECIAL recommends CONDITIONS. (District 1)

Completion of the following requirements within five years from the date the rezoning request is approved by the Board of Supervisors:

- 1. There shall be no further lot splitting or subdividing of residential development without the written approval of the Board of Supervisors.
- 2. Transportation conditions:
 - A. The developer shall dedicate a minimum of 45 feet of right-of-way, or sufficient rightof-way to construct the first half of the Linda Vista extension.
 - B. The developer shall dedicate 30 feet of right-of-way for Linda Vista at the south east corner of Linda Vista and Shannon Road as shown on the preliminary development plan.
 - C. The extension of Linda Vista Road shall align with the existing intersection of Linda Vista and Shannon Road.
 - D. The developer shall be required to construct Linda Vista Road for the entire frontage of the rezoning site.
 - E. An easement for future access to the school shall be provided as shown on the preliminary development plan.
 - F. Sidewalk or a multi-use path shall be constructed along Freer Drive to provide safe pedestrian access to Ironwood Elementary School.
 - <u>G.</u> Linda Vista Blvd. roadway improvements to be constructed by the developer shall generally be consistent with those agreed to with the Pima County Department of Transportation. Roadway development impact fees for the entire development shall be waived subject to the following:
 - 1) The portion of Linda Vista Blvd. along the project frontage west of Shannon Rd. shall be constructed in two phases. Phase 1 of the Linda Vista Blvd. improvements, which is the segment from Shannon Rd. west to the project entrance, shall be developed concurrently with initial project construction.
 - Phase 1 improvements consist of the full 90 foot cross section depicted as <u>Standard Detail #10, Major Collector Street Urban Residential Subdivision</u> <u>as outlined in the Pima County Subdivision and Development Street</u> Standards.
 - 3) Construction of the Phase 2 of the Linda Vista Blvd. improvements, which is the segment west of Phase 1 extending to the west edge of the project's

Linda Vista Blvd. frontage, shall begin no later than the application for the 51st building permit on the portion of the project lying to the west of Shannon Road.

- 4) Phase 2 improvements consist of the south half of the full 90 foot cross section depicted as Standard Detail #10, Major Collector Street Urban Residential Subdivision as outlined in the Pima County Subdivision and Development Street Standards.
- 5) Both Phases of this project's obligated Linda Vista Blvd. improvements shall be completed prior to release of final assurances for the project.
- 6) <u>Should the property to the north advance construction of north half of Linda</u> <u>Vista before the phasing threshold is met, the developer would advance</u> <u>construction of the south half concurrently.</u>
- 3. Regional Flood Control District conditions:
 - A. Water conservation measures identified in the Preliminary Integrated Water Management Plan shall be implemented with the development. Where necessary as determined at the time development plan is submitted, provisions for permanent maintenance of these measures may also be required to be included in the project's CC&Rs and a Final Integrated Water Management shall be submitted to the District for review and approval at the time of development.
 - B. First flush retention (retention of the first ½ inch of rainfall) shall be provided for all newly disturbed and impervious surfaces including roads. This requirement shall be made a condition of the Site Construction Permit.
- 4. Regional Wastewater Reclamation conditions:
 - A. The owner shall not construe any action by Pima County as a commitment to provide sewer service to any new development within the rezoning area until Pima County executes an agreement with the owner to that effect.
 - B. The owner shall obtain written documentation from the Pima County Regional Wastewater Reclamation Department (PCRWRD) that treatment and conveyance capacity is available for any new development within the rezoning area, no more than 90 days before submitting any tentative plat, development plan, preliminary sewer layout, sewer improvement plan, or request for building permit for review. Should treatment and/or conveyance capacity not be available at that time, the owner shall enter into a written agreement addressing the option of funding, designing and constructing the necessary improvements to Pima County's public sewerage system at his or her sole expense or cooperatively with other affected parties. All such improvements shall be designed and constructed as directed by the PCRWRD.
 - C. The owner shall time all new development within the rezoning area to coincide with the availability of treatment and conveyance capacity in the downstream public sewerage system.
 - D. The owner shall connect all development within the rezoning area to Pima County's public sewer system at the location and in the manner specified by the PCRWRD in its capacity response letter and as specified by PCRWRD at the time of review of the tentative plat, development plan, preliminary sewer layout, sewer construction plan, or request for building permit.
 - E. The owner shall fund, design and construct all off-site and on-site sewers necessary to serve the rezoning area, in the manner specified at the time of review of the tentative plat, development plan, preliminary sewer layout, sewer construction plan or request for building permit.
 - F. The owner shall complete the construction of all necessary public and/or private sewerage facilities as required by all applicable agreements with Pima County and all applicable regulations, including the Clean Water Act and those promulgated by ADEQ, before treatment and conveyance capacity in the downstream public sewerage system will be permanently committed for any new development within the rezoning area.

- 5. Environmental Planning conditions:
 - Α. The property owner shall achieve compliance with the Maeveen Marie Behan Conservation Lands System conservation guidelines by providing a total of 107 acres as Natural Open Space (NOS). Should the developed area be reduced from that which is reflected in the PDP, the property owner shall provide a minimum of 4 acres of natural open space for every acre developed to achieve full compliance with the MMBCLS conservation guidelines. No less than 49 acres NOS will be provided on-site and will conform to the approximate location and configuration shown on the approved Preliminary Development Plan. The difference between the total 107 acres (or less depending upon developed area) NOS and NOS provided on-site will be provided off-site. Off-site NOS must conform to the CLS Off-site Mitigation Policies (Pima County Comprehensive Plan 2015, Chapter 3 Use of Land Goals and Policies, Section 3.4 Environmental Element, Policy 11 of Conservation Lands System Mitigation Lands) and comply with all of the following:
 - Off-site NOS is acceptable to the Pima County Planning Official or their 1) designee; and
 - 2) Prior to the approval of the final plat, off-site NOS will be permanently protected as natural open space by a separately recorded legal instrument acceptable to the Pima County Planning Official or their designee.
 - Β. Upon the effective date of the Ordinance, the owner(s)/developer(s) shall have a continuing responsibility to remove invasive non-native species from the property, including those below. Acceptable methods of removal include chemical treatment, physical removal, or other known effective means of removal. This obligation also transfers to any future owners of property within the rezoning site and Pima County may enforce this rezoning condition against the property owner. Prior to issuance of the certificate of compliance, the owner(s)/developer(s) shall record a covenant, to run with the land, memorializing the terms of this condition.

- 6. Cultural Resources conditions:
 - In the event that human remains, including human skeletal remains, cremations, Α. and/or ceremonial objects and funerary objects are found during excavation or

construction, ground disturbing activities must cease in the immediate vicinity of the discovery. State laws ARS 41-865 and ARS 41-844, require that the Arizona State Museum be notified of the discovery at (520) 621-4795 so that cultural groups who claim cultural or religious affinity to them can make appropriate arrangements for the repatriation and reburial of the remains. The human remains will be removed from the site by a professional archaeologist pending consultation and review by the Arizona State Museum and the concerned cultural groups.

Chris Poirier, Deputy Director, Development Services, addressed the Board indicating that the standard and special conditions were modified by the Department of Transportation, these modifications included 2A thru D, Transportation conditions, and 5A, Environmental Planning conditions. He added that the applicant was comfortable with the modifications.

Chair Bronson indicated that Artie Eaves from Sanders and Parks, was the attorney retained by Maricopa County. She added that the firm was asked to clarify their scope of responsibilities and if they are retained by Pima County a similar request should be made.

It was moved by Chair Bronson and seconded by Supervisor Miller to retain Artie Eaves of Sanders and Parks on an as-needed basis.

Supervisor Valadez sought clarification on the motion, whether it included Mr. Huckelberry's recommendation that this be on a case-by-case basis as authorized by the Board.

Chair Bronson concurred. No vote was taken at this time.

Supervisor Miller expressed concern with Barbara LaWall's, County Attorney, memo to Mr. Huckelberry regarding recent expenditures that included sending victim advocates and volunteers to assist in the Las Vegas shooting, and her refusal to provide documentation from the Nevada Attorney General. She indicated that the Board was advised that all documentation would be made available online, misinformation was provided regarding the employees and volunteers sent to assist and that a possible conflict of interest may exist within the County Attorney's Office. She asked that upon retention of outside counsel a review of the memorandum be conducted. Supervisor Valadez inquired whether Maricopa County had been provided clarification regarding their Board's scope of responsibilities from outside counsel.

Chair Bronson responded that Maricopa County had been provided clarification and that Pima County could submit a request for that documentation, but that she would also like outside counsel to review the memorandum released by Ms. LaWall, which Ms. LaWall cited priviledged.

Mr. Huckelberry indicated that if the Board decided to employ outside counsel, they could request a copy of the clarification memo produced for Maricopa County, seek further clarification on the Board's scope of responsibilities, and determine whether an additional opinion was necessary for Ms. LaWall's memorandum.

Supervisor Valadez questioned if those were bifurcated motions.

Chair Bronson clarified that the motion on the floor was to retain outside counsel.
