*Purpose:

The purpose of Southwest Books of the Year is to provide guidance in the selection and appreciation of literature of the Southwest and a tool to select the best of the current titles about the Southwest region.

*Procurement Method:

Not applicable to grant awards.

*Program Goals/Predicted Outcomes:

Southwest Books of the Year will make a significant contribution toward meeting the public's need for a comprehensive and critical guide to Southwest writing.

*Public Benefit:

Approximately 11,000 copies of Southwest Books of the Year, containing reviews of the best of the current titles from the region, will be distributed locally through libraries and bookstores, and throughout the state of Arizona.

*Metrics Available to Measure Performance:

Feedback forms are collected from the public, libraries, bookstores and other venues around Arizona. The Arizona State Library is responsible for reporting to the Institute of Museum and Library Services

*Retroactive:

Yes. The grantor -- Arizona State Library -- requested that a mini-grant application be submitted on November 1. through an on-line survey tool. The Pima County Public received the notice of award on November 23. 2017, with the grant effective date of 11/1/2017. If the funding is not approved Southwest Books of the Year will not be distributed throughout the state of Arizona.
