The goal of the project is to provide a welcoming space for youth and adult educational workforce programs that are not possible in the current space.

The reorganization of service points, and meeting areas, and changes to the entrance of the Sam Lena South Tucson Branch Library will created a safer, more welcoming environment for library customers and for the community.

Project completion rates will be evaluated; project will be completed in accordance with long range facilities plans and library utilization recommendations; the project will be completed in accordance with grant requirements.

Yes. Pima County Public Library (PCPL) finished the intent to apply 9/7/2017 received the Award Notification on 12/1/2017 with a 12/1/2017 start date. SGIAC funds are a reimbursement; and funds will be awarded when construction is completed (currently estimated at 6/30/2018). If grant award is not approved, PCPL will not receive the \$50,000.00 distribution in June.
