**Title:** Temporary Road Closure Resolution

**Introduction/Background:**

The reason for this resolution is that Pima Velo has requested the temporary closure of portions of Mission Road, Continental Road, Duval Mine Road and Helmet Peak Road for the Tucson Bicycle Classic event on March 17, 2018 from 4:00 A.M. to 2:00 P.M.

**Discussion:**

As a result of the request, and Special Event Permit Application review, Pima County Traffic Engineering recommends the temporary closure of portions of Mission Road, Continental Road, Duval Mine Road and Helmet Peak Road.

**Conclusion:**

Pima County Traffic Engineering recommends the temporary closure of portions of Mission Road, Continental Road, Duval Mine Road and Helmet Peak Road to enhance the safety of the Tucson Bicycle Classic event by reducing the potential for vehicular conflicts.
