Requested Board Meeting Date: April 3, 2018

Title: Sage Street No Stopping, Standing or Parking Ordinance

Introduction/Background:

Mesa Verde Elementary School is located at the west end of Sage Street between Romero Avenue and La Canada Drive. A citizen request was received for the installation of No Parking signs on Sage Street due to vehicles blocking mailboxes, driveways and parking on private property.

Discussion:

The queuing and parking capacity of Mesa Verde Elementary School is not sufficient for the number of vehicles accessing the school. As a result, Pima County Department of Transportation staff observed vehicles queuing onto Sage Street and Romero Avenue, and parking on both sides of Sage Street in the vicinity of the school crosswalk.

Conclusion:

No Stopping, Standing or Parking signs are recommended for installation on both sides of Sage Street in the vicinity of the school crosswalk. This is a recommended application per the Arizona Department of Transportation's Traffic Safety for School Areas Guidelines. This will also reinforce Arizona Revised Statute 28-901, which prohibits children from being received or discharged from a vehicle on the side of a highway opposite from which the school is located.

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, RELATING TO TRAFFIC AND HIGHWAYS; REGULATING PARKING ON SAGE STREET IN PIMA COUNTY, ARIZONA

THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA FINDS THAT:

- 1. The Board of Supervisors of Pima County, Arizona has authority under A.R.S. § 28-627 and 28-873 to regulate the stopping, standing and parking of vehicles.
- 2. The Board of Supervisors has determined that it is in the interest of public safety that vehicles should not stop, stand or park on portions of Sage Street in Pima County, Arizona.

BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA:

SECTION 1. Parking on both sides of Sage Street shall be regulated as No Stopping, Standing or Parking for the following segments:

From	<u>To</u>
Romero Avenue	Date Street

SECTION 2. All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take into effect when and to the extent that no stopping, standing or parking signs are posted on the highway herein giving notice of the parking restriction.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
