

# **BOARD OF SUPERVISORS AGENDA ITEM REPORT**

Requested Board Meeting Date: August 7, 2018

Title: Tanque Verde Road at Tanque Verde Loop Road; Acq-0616

### Introduction/Background:

Pima County needs to acquire a Temporary Construction Easement (TCE) from First American Title TR 9154 for a portion of parcel 205-37-5700 for construction staging area for the Tanque Verde Road at Tanque Verde Loop Road Intersection improvements. There are no alternative locations available because they weren't cleared by NEPA.

#### Discussion:

The County has been unable to acquire the TCE through negotiation and requests condemnation authority. The County obtained an appraisal from an independent appraiser in the amount of \$8,100 for a two year TCE, with a breakdown of \$2.50 per sf X 18,000 sf X 9% Rate of Return (TCE Rent) x 2 years. The Owner has requested \$50,169.00 and has also insisted on relocating the TCE. The requested location isn't feasible due to the impacts to natural vegetation and no NEPA clearance.

# Conclusion:

The TCE is necessary for the project and should be acquired through condemnation, so that it can be acquired at a fair price.

#### Recommendation:

Staff recommends approval of the attached Resolution authorizing condemnation.

#### Fiscal Impact:

The County will acquire the property at a price arrived at through condemnation, either by settlement or trial.

# The Board of Supervisors of Pima County, Arizona finds:


- 1. Pima County plans to make intersection improvements in connection with the Tanque Verde Road at Tanque Verde Loop Road Intersection (the "Project") located in Section 31 of Township 13 South, Range 16 East, G&SRM, for the use and benefit of the public; and
- 2. The Board of Supervisors of Pima County finds it is necessary to exercise its powers of eminent domain, pursuant to A.R.S. § 12-1111, to acquire a temporary construction easement on the real property depicted in attached **Exhibit A** in order to construct the Project;

**NOW, THEREFORE, BE IT RESOLVED** that the Pima County Attorney be and is hereby authorized to institute condemnation proceedings to acquire a temporary construction easement necessary for the above described Project, on the real property shown on the attached **Exhibit A**.


