Re: August 13, 2018 Community Law Enforcement Partnership Commission

Honorable Chair and Members of the Board of Supervisors,

As Co-Chairs of the Community Law Enforcement Partnership Commission (CLEPC), we are writing to provide you with an update to the Board of Supervisors request at the August 7, 2018 meeting that our Commissioners consider recommendations whether to accept the grant funds for both Operation Stonegarden and HIDTA (High Intensity Drug Trafficking Area) program.

First, we would like to say that we consider it an honor to be appointed by our Supervisors to serve our Pima County community in this capacity and fully understand the seriousness of the roles and responsibilities in which we have been placed.

After receiving Sheriff Mark Napier's OPSG overview presentation at our July 9 meeting and receiving presentations by the Criminal Justice Reform Unit at our August 13 meeting about 1) OPSG's Daily Activity Reports, 2) County Administrator Chuck Huckelberry's August 7, 2018 OPSG update memorandum and recommendations, and 3) the ACLU of Arizona's response to the Sheriff's Department's newly created policy directing how sheriff deputies will interact with Federal Immigration Officials, Commissioners discussed the two action items requested of us by the Board of Supervisors.

About HIDTA.

Commissioners voted five to one to recommend approval to accept the HIDTA grant.

About OPSG.

After several attempts to arrive at a decision, Commissioners were unable to make a recommendation to the Board of Supervisors. It should be noted that Commissioners extended the meeting by 50 minutes and even tried to schedule another meeting prior to the Board's September 4 convening, but in the end, we felt we were not in a position – and more importantly, we did not have the votes – to make a decision for or against the acceptance of OPSG grant funds.

We do not come to this conclusion lightly as we are aware of the ramifications our decision may have.

We believe the Commission has brought together an opportunity for community advocates and stakeholders to have honest, candid, and difficult discussions with law enforcement agencies, most notably the Sheriff's Department and Sheriff Napier, about the impacts unfair and unjust immigration enforcement has on our Pima County residents and community.

We look forward to continued dialogue and further understanding of the impacts of implementing OPSG in Pima County and our collective work in addressing potential racial and ethnic disparities to vulnerable populations.
