Outside Agency Recommendation Regarding Funding Related to Rejected County Attorney
Anti-Racketeering Fund Recommendations

Background

As the Board recalls, outside counsel reviewed a number of County Attorney Antiracketeering fund recommendations and determined, in the opinion of outside counsel, the agencies did not qualify for Anti-racketeering/Racketeer Influenced and Corrupt Organizations (RICO) funding. I then referred each of the requesting agencies, who were rejected RICO funding and who had not received previous funding from the County, to the Outside Agency Review Committee for their review and recommendation.

The Outside Agency Review Committee held a public meeting on August 17, 2018 to review these requests. The Committee determined the type of funding and recommended for all 10 agencies as outlined in their August 23, 2018 recommendation to the Board of Supervisors.

Recommendation

I recommend the Board of Supervisors authorize funding these outside agencies from the Contingency Fund for at risk youth services in the amount of \$38,000 and the County Attorney dedicate an equivalent amount of RICO funds to domestic violence, strangulation and forensic testing.

FY2018 Funding Recommendations for Outside Agencies

Background:

The Outside Agency Community Advisory Committee (the Committee) is a panel of five members appointed by the Board of Supervisors to serve as their representatives and one member appointed by the County Administrator. The Community Development and Neighborhood Conservation Department (CDNC) staff this Committee.

On August 7, 2018, the Committee received a special request to review and make recommendations on ten agency applications for funding. The ten agencies initially solicited applications for funding from the County Attorney facilitated Anti-Racketeering (RICO) Funds. However, an outside legal counsel had recently issued a determination that the agencies did not qualify for RICO funding per applicable statutes. Upon further review, the County Administrator's Office had determined that the programs may be worthy of receiving other identified, non-Outside Agency Program, general funds pending a review and recommendation of the Committee.

Discussion:

The Committee held an open public meeting on August 17, 2018 at the Pima County Housing Center. CDNC staff provided background information per the special request and addressed questions from Committee members. Staff also provided an overview of each agency proposal based upon their initial RICO applications and information gathered on their respective websites. Staff determined that the agencies met the minimum requirements for outside agency type funding per applicable A.R.S. § 11-1041 and 11-1042 through their service to at-risk youth. A combined total of \$38,000 was requested from the ten agencies with other non-Outside Agency Program funds identified from the County Administrators Office. There were no public comments from the audience in attendance.

Recommendation:

Serving as the Chair of the Committee, I commend the County Administrator and Board of Supervisors for their efforts to fund agencies that provide a valuable service to youth in both rural

and urban areas of Pima County. Each member of the Committee acknowledges the duty that we have to evaluate services for at-risk youth and determine eligibility of proposals for County funds.

Upon review of the applications at the public meeting, the Committee unanimously recommends that all 10 proposals to fund youth activities be awarded available funding in the amounts identified in their respective requests as attached.

4. COMMITTEE SPECIAL REQUEST OVERVIEW

Mr. Daniel Tylutki provided background regarding the special request for the OA Committee to review 10 proposals from agencies initially applying for RICO funds facilitated by the County Attorney's Office. Tylutki explained that a recent outside legal counsel interpretation identified the 10 applications, some of which had been funded RICO resources in the past, as ineligible per Arizona Revised Statutes (ARS). The briefing continued with an explanation that all the 10 applications for consideration were youth oriented with funding requests at or less than \$5,000, and though the proposals might not meet the interpreted statutory nexus for RICO funds at this time, they meet the minimum ARS requirements for Outside Agencies type programs. Provided this information, Tylutki concluded that other, non-Outside Agency Program, general funds had been identified to fund the agencies should the Committee review also warrant funding the proposals.
