

Re: **Error in Denying Operation Stonegarden Contract Amendment 160404-03**

When the Operation Stonegarden (OPSG) grant was considered on the September 4, 2018 Regular Agenda, an OPSG Subgrantee Agreement Amendment #1 (160404-03) was placed on the Addendum. The amendment language read as if it was an expansion of the funding available for OPSG. In reality, the Amendment was for reimbursement for work that had already taken place.

I inquired of the Sheriff on September 10, 2018 for clarification and Sheriff's Operations Bureau Chief Karl Woolridge responded. Chief Woolridge indicated the funds are for reimbursement of services already provided during Fiscal Year 2016.

Therefore, to correct this error, I request the Board of Supervisors approve this amendment to receive reimbursement funding for expenses already incurred on OPSG for Fiscal Year 2016 in the future.

Re: **Operation Stonegarden Grant Amendment 1 Award 160404-03 Overtime and Mileage**

At the September 4, 2018 Board of Supervisors Meeting, the Operation Stonegarden grants 170405-02 and 170405-03 were terminated. In addition, Addendum 7 on the same Board Agenda appeared to add \$47,350 to the same contract. The amendment document simply indicates the amount of funding to be received was increased from \$1,176,208 to \$1,223,558, which would lead one to believe that it was for services not yet performed. However, the grant number effective date indicates that it is from November 1, 2016 to December 31, 2017, which tends to indicate it is reimbursement for services already performed by the Sheriff's Department. If this is the case, the amendment should have been approved and not denied by the Board of Supervisors even though the attached grant documents would mislead one to believe that the funding was increased for the OPSG grant.

Please clarify as to whether this is an increase in the total amount of the grant to allow for an additional \$47,350 to be expended in overtime or if this is a reimbursement for services already provided for the designated grant period of November 1, 2016 to December 31, 2017. If it is for reimbursement rather than increased services, I will ask the Board to reconsider denial of the amendment and approve it as it reimburses Pima County for funds already spent on Operation Stonegarden even though the grant documents are somewhat misleading.

SUBGRANTEE AGREEMENT Amendment #1
16-AZDOHS-OPSG-160404-03
Between
The Arizona Department of Homeland Security
And
Pima County Sheriff's Department

WHEREAS, A.R.S. § 41-4254 charges the Arizona Department of Homeland Security (AZDOHS) with the responsibility of administering funds.

Pursuant to Section XII of the subgrantee Agreement between the Arizona Department of Homeland Security and the subgrantee the following section of the above referenced Subgrantee Agreement is hereby amended as follows:

III. DESCRIPTION OF SERVICES:

The subrecipient shall provide the services for the State of Arizona, Arizona Department of Homeland Security as approved in the grant application titled "**OPSG Overtime and Mileage**" and funded at **\$1,176,208** (as may have been modified by the award letter).

SHALL BE CHANGED TO READ:

The subrecipient shall provide the services for the State of Arizona, Arizona Department of Homeland Security as approved in the grant application titled "**OPSG Overtime and Mileage**" and funded at **\$1,223,558** (as may have been modified by the award letter).

IV. MANNER OF FINANCING:

The AZDOHS shall:

Provide up to **\$1,176,208** to the subrecipient for services provided under Paragraph III.

SHALL BE CHANGED TO READ:

Provide up to **\$1,223,558** to the subrecipient for services provided under Paragraph III.

X. REPORTING REQUIREMENTS

Regular reports by the Subrecipient shall include:

f) Financial Reimbursements

The Subrecipient shall provide AZDOHS request for reimbursement as frequently as monthly but not less than quarterly. Reimbursement requests are only required when expenses have been incurred. Reimbursement requests shall be submitted with the Reimbursement Form provided by the AZDOHS staff. The Subrecipient shall submit a final reimbursement request for expenses received and invoiced prior to the end of the termination of this Agreement no more than **forty-five (45) calendar days** after the end of the Agreement. Requests for reimbursement received by AZDOHS later than **forty-five (45) calendar days** after the Agreement termination will not be paid. The final reimbursement request as submitted shall be marked as final.

SHALL BE CHANGED TO READ:

f) Financial Reimbursements

The Subrecipient shall provide AZDOHS request for reimbursement as frequently as monthly but not less than quarterly. Reimbursement requests are only required when expenses have

been incurred. Reimbursement requests shall be submitted with the Reimbursement Form provided by the AZDOHS staff. The Subrecipient shall submit a final reimbursement request for expenses received and invoiced prior to the end of the termination of this Agreement no more than **Two Hundred and Seventy-Three (273) calendar days** after the end of the Agreement. Requests for reimbursement received by AZDOHS later than **Two Hundred and Seventy-Three (273) calendar days** after the Agreement termination will not be paid. The final reimbursement request as submitted shall be marked as final.

All other terms of the original Subgrantee Agreement remain effective.

In Witness Whereof, the parties have set their hands to this AMENDMENT as of the day and year herein indicated and agree that all parties are obligated to follow all terms and conditions of the original subgrantee agreement and are liable for all funds received by the AZDOHS.
