Memorandum of Understanding and Grant from the Department of Public Safety Regarding the Border Strike Force for Prosecution and Detention Expenses

Background

A Memorandum of Understanding, referenced as Arizona Department of Public Safety (DPS) Contract No. 2018-095, was sent directly to Supervisor Ramon Valadez's Office. I will place the grant on Board of Supervisors Addendum for acceptance.

The grant requires a report to DPS detailing actual expenditures for prosecution and detention expenses of the County. Our new Grants Management and Innovation Department will be responsible for reporting the information, which should be easily obtained since we produce reports related to occupancy of the Pima County Adult Detention Complex by offense and citizenship on a weekly basis. I will also ask the County Attorney to provide similar statistics.

Recommendation

I recommend accepting Arizona Department of Public Safety Contract No. 2018-095 in the amount of \$166,666.66 as it is for solely offsetting prosecutorial and jail expenses incurred from individuals charged with drug trafficking, human smuggling, illegal immigration and other border related crimes. The Grants Management and Innovation Department will provide grant compliance through cooperation with the Sheriff and the County Attorney.
