*Project Title/Description:

Arizona Department of Housing - Pima County Links, a housing and employment program for people experiencing homelessness in Pima County. The original contract may be found under CT-CS-17*404. Search contract number 17%404 in eContracts.

*Purpose:

This amendment with Compass Affordable Housing, a partner agency with Pima County Links, is to provide five Pima County residents with prevention assistance services. There is no additional funds being added to this amendment.

*Procurement Method:

RFP-CSET- 2015-4 per Pima County Board of Supervisors Policy D29.6 - Selection and Contracting of Professional Services.

*Program Goals/Predicted Outcomes:

The program will provide rapid rehousing to a minimum of thirty participants (a homeless family is considered one participant). Compass Affordable Housing will serve 65% of individuals/families within the first six months of the contract and ensure that 95% of individuals/families will exit to permanent housing within sixty days of entering the program. Five individuals/families will receive prevention assistance services to avoid potential homelessness.

*Public Benefit:

The program provides the resources necessary for households experiencing homelessness in Pima County to obtain employment and housing.

*Metrics Available to Measure Performance:

Arizona Department of Housing requires its programs to enter information, provide reports, and track program participants through the Homeless Management Information System (HMIS).

- D. Awardee satisfactorily provided homeless prevention services in 2017-2018 and has agreed to provide such services for the remainder of the 2018-2019 contract year.
