# Title: Temporary Road Closure Resolution

### Introduction/Background:

Brooksee, LLC has requested the temporary closure of portions of Sabino Canyon Park, General Hitchcock Highway, Catalina Highway, Melpomene Way, Snyder Road and portions of the adjacent minor streets and driveways for the Revel Mount Lemmon Marathon and Half event on Saturday, November 3, 2018 from 3:00 A.M. to 2:00 P.M.

### Discussion:

After review of the request, Pima County Transportation recommends the temporary closures to enhance the safety of the Revel Mount Lemmon Marathon and Half event. General Hitchcock Highway will be facilitated by a pilot car system in coordination with the Pima County Sheriff's Department.

#### **Conclusion:**

Pima County Transportation recommends the temporary closure of portions of Sabino Canyon Park, General Hitchcock Highway, Catalina Highway, Melpomene Way, Snyder Road and portions of the adjacent minor streets and driveways to enhance the safety of the Revel Mount Lemmon Marathon and Half event by reducing potential vehicular conflicts.
