A full road closure on La Canada Drive will be in effect from Paseo del Prado/Calle de las Casitas to Desert Bell Drive/ La Canoa and on Esperanza Boulevard from Las Yucas to Paseo Pena.

The Board of Supervisors of Pima County, Arizona finds:

- 2. Country Fair White Elephant, Inc. has requested the temporary closure of portions of La Canada Drive from San Ignacio to Calle Lecho and Esperanza Boulevard from Camino del Portillo to Interstate 19. A full road closure on La Canada Drive will be in effect from Paseo del Prado/Calle de las Casitas to Desert Bell Drive/La Canoa and on Esperanza Boulevard from Las Yucas to Paseo Pena on Saturday, October 27, 2018 from 8:30 A.M. to 1:00 P.M. to facilitate this event.
- 3. The Pima County Board of Supervisors has determined that it will be necessary to permit the temporary closure of portions of La Canada Drive and Esperanza Boulevard to support this event.
