#### \*Purpose:

To provide 2018 Water Year report preparation and printing, as well as other Living River Project Activities including oversight, partner coordination, and community outreach.

#### \*Procurement Method:

Direct Select D 29.6 C

#### \*Program Goals/Predicted Outcomes:

The goal is to report annually regarding changes in the wetland ecosystem along the Santa Cruz River. The predicted outcome is heightened stakeholder and community awareness about the status of this resource and action to preserve, protect and enhance the community benefit from it. Project also dovetails with development of Santa Cruz River Management Plan.

#### \*Public Benefit:

Pima County will continue its efforts begun with the EPA grant-funded Living River Project. The public will benefit by having available annual reporting and outreach regarding the wetland health of the Santa Cruz River ecosystem. Information in the report has been showing results of water quality improvement from upgrades to the county's metropolitan wastewater reclamation facilities.

#### \*Metrics Available to Measure Performance:

Report is produced and printed as a hard-copy deliverable. Number of direct mail reports will be tabulated. Also, Sonoran Institute tracks and reports outreach activities, including a summary of tabling events and media inquiries/interviews. Material is posted to Sonoran Institute website that is monitored for "hits."

#### \*Retroactive:

Yes. This contract renewal was initiated in September allowing for plenty of time to process before the expiration date of October 31, 2018. During the renewal processing, an oversight occurred in that BOS D29.4 states (Section XII. A. Contract Approval) that contracts for professional services greater than \$100,000 must be approved and executed by the BOS. If this contract renewal isn't approved, RWRD will not be providing its share of project funding to coincide with RFCD funding on the Living River Project. As a result Sonoran Institute would not be able to continue the Living River Project work, and most immediately, we would miss conducting this year's fish survey of the river.

Attached for your review and approval is Contract Amendment Number Two (2) for the Regional Wastewater Reclamation Department (RWRD) with the Sonoran Institute for supplemental services to the Living River Project.

This contract amendment will follow a 6-year effort which Pima County has engaged in with the Sonoran Institute to conduct the Living River Project, initiated with grant funds provided to Pima County by EPA through September 2016. The Sonoran Institute partnered with Pima County to secure the grant from the Environmental Protection Agency (EPA), which has now expired. However, this continuing work builds on the data already collected and analyzed under the EPA grant work and the contract amendment will facilitate further characterization of the improvements in the river system.

This project is entering the sixth year of environmental monitoring of the Lower Santa Cruz River. This monitoring is designed to study the impact of improved water quality from the \$605 million Regional Optimization Master Plan (ROMP) upgrading the Tres Rios and Agua Nueva Water Reclamation Facilities. To continue this project work for the 2018 water year, RWRD and the Regional Flood Control District (RFCD) are providing in-kind staff support as well as supplemental funding for project activities. RWRD and RFCD wish for the Sonoran Institute to continue in their role of providing professional services necessary to completing this project for the 2018 water year.

The original RWRD contract with the Sonoran Institute of October 2012 provided \$45,000 for the first year of the Project. These supplemental services were for oversight, implementation and outreach activities, which included (1) project and partner coordination (2) technical committee support (3) the annual Santa Cruz River Researcher's Day Workshop/Seminar and (4) tracking and evaluating project outcomes. Following successful completion of these activities in the 2012/13 grant year, we amended the contract to include website development and annual report preparation with amendments adding \$30,000 in grant year 2013/14; \$29,000 in grant year 2014/15 and \$33,000 in grant year 2015/16. In September 2016, a new contract in the amount of \$40,000 was issued to cover costs for the work during water year 2016. An amendment in 2017 extended the contract for another year in the amount of \$32,000.

During this entire project period, the Sonoran Institute worked with Pima County to publish a comprehensive study of historical conditions along the Lower Santa Cruz River. The Sonoran Institute also compiled and distributed a detailed Selection Process Report documenting the year-long work of scientists on the Technical Committee to develop environmental indicators of the health of an effluent depended stream. In the second grant year, an annual report was produced documenting baseline stream conditions.

The past four year' work by the Sonoran Institute in partnership with Pima County produced annual reports showing significant progressive improvements in ecosystem health, with the latest data showing return of the endangered Gila topminnow, a native fish to the river habitat. Another yearly report will likely confirm the improving trend and inform the County's efforts in developing a river management plan.

RWRD recommends that Pima County continue to fund these supplemental support activities for an additional year ending October 31, 2019. The cost of this amendment will be \$33,000 and is to be added to the previous contract amount. Services will support the 2018 water year report preparation and printing, as well as the other related Living River Project activities identified in the contract's Scope of Services.

The budget for the project will be \$33,000 with RWRD and RFCD contributing data, interpretation, and oversight of the report production services and related activities. The funding will cover the costs of producing the reports as well as the development, coordination and implementation of the collected data. The departments are confident that the collected technical data, which form a basis for the Living River reports, website and related activities will be handled and compiled in a professional manner for purposes of Pima County's Living River Project.

# Exhibit A: Scope of Services Project Period November 1, 2018 through October 31, 2019

### Task 1: Oversight, Implementation, and Outreach\*

# 1.1: Project and Partner Coordination (Estimated at \$14,000; \$7,000 provided by Pima County Regional Wastewater Reclamation Department)

- Provide project oversight, management, and coordination
- Coordinate project meetings with staff and selected partners
- Provide regular reports and meeting notes/summaries

### 1.2: Living River Report (Estimated at \$43,800; \$21,900 provided by PCRWRD)

- Coordinate and implement the 6<sup>th</sup> fish survey that provides data for the 2018 water year
- Lead data synthesis, writing, and production of the report for 2018 water year (includes report design and printing, direct mail of ~3500 reports, and online supplemental report)

### 1.3: Community Outreach (Estimated at \$14,200; \$4,100 provided by PCRWRD)

- Develop and implement community presentations sharing project information particularly focused on 5<sup>th</sup> and 6<sup>th</sup> reports, hosting/tabling at events, report reception
- Respond to and develop content for media inquiries
- Promote project on Sonoran Institute website
- Estimate outreach impact by tracking report downloads and estimated reach with project activities including presentations, events, Living River of Words
- Coordinate demonstrations of fish survey methods with students/public

Living River Project<sup>™</sup> Intellectual Property and Communication Guidelines — Living River<sup>™</sup> Reports were launched in 2007 when Sonoran Institute began tracking conditions of the stretch of the Santa Cruz River in Santa Cruz County that flows year round. This annual series was expanded in cooperation with Pima County to include the flowing reach near Tucson in 2012. Tasks and activities performed in the scope of work under this Contract are thus part of the "Living River Project<sup>™</sup>," designed to evaluate and communicate to the public the environmental health and water quality of the Santa Cruz River in northwest Tucson and Marana.

The parties acknowledge that Sonoran Institute owns the trade name and service mark "Living River<sup>TM</sup>" for its Santa Cruz River work and programs which predate and are beyond the scope of this Contract. However, Sonoran Institute grants Pima County a cost-free, non-transferable, irrevocable license to use the trade names "Living River<sup>TM</sup>" and "Living River Project<sup>TM</sup>" during the term of this Contract (including all renewals and extensions). Sonoran Institute also shall acknowledge support of Pima County for all materials and work produced under this Contract. Pima County shall note in its relevant publications that the trade names "Living River<sup>TM</sup>" and "Living River Project<sup>TM</sup>" are property of Sonoran Institute and used with permission.

\*Other pending funding to Sonoran Institute by PCRFCD will cover remaining amount of the estimated expenses.
