### CONTRACT AMENDMENT

The parties agree to amend the above-referenced contract as follows:

**1. Background and Purpose.**

- 1.1. Background. On September 30, 2014 County and Contractor entered into the above referenced agreement to provide Implementation of Enhancements to Pima County Drug Court Program and Establishment of a Drug Treatment Alternative to Prison Program
- 1.2. Purpose. To provide participants treatment services from our SAMSHA Drug Courts, Substance Abuse and Mental Health Services Administration Center for Substance Abuse Treatment grants.

**1. Term.** The Contract terminates on September 29, 2019.

**2. Maximum Payment Amount.** The maximum amount the County will spend under this Contract, as set forth in Article III is increased by \$25,000.00. County's total payments to Contractor under this contract, including any sales taxes, will not exceed \$267,000.00.

The effective date of this Amendment is September 30, 2018.

All other provisions of the Contract not specifically changed by this Amendment remain in effect and are binding upon the parties.
