### CONTRACT AMENDMENT

The parties agree to amend the above-referenced contract as follows:

**1. Background and Purpose.**

- 1.1. Background. On October 1, 2015 County and Contractor entered into the above referenced agreement to provide Pima County Enhancing Drug Court Services, Coordination and Treatment.
- 1.2. Purpose. Community Intervention Associates (CIA), through its contract with Cenpatico, shall enroll DTAP Title XIX eligible members, so they can receive residential substance abuse treatment services or intensive outpatient treatment.

- 1. **Term.** The Contract terminates on September 29, 2019.
- 2. **Maximum Payment Amount.** The maximum amount the County will spend under this Contract, as set forth in Article III is increased by \$70,750.00. County's total payments to Contractor under this contract, including any sales taxes, will not exceed \$320,750.00.

The effective date of this Amendment is September 30, 2018.

All other provisions of the Contract not specifically changed by this Amendment remain in effect and are binding upon the parties.




