Title: Ordinance to Regulate Traffic at Los Pinos Vista and Yucca Via

Introduction/Background:

The Pima County Department of Transportation received a citizen request for the installation of a stop sign at the intersection of Los Pinos Vista and Yucca Via. The citizen indicated that several near misses have been observed at the intersection. Los Pinos Vista and Yucca Via are local roadways with a 25 mph speed limit. Los Pinos Vista terminates at Yucca Via at the west end. Los Pinos Vista is approximately 80 feet south of Sahuaro Vista.

Discussion:

A study was conducted at the intersection of Los Pinos Vista and Yucca Via to determine if stop control was recommended for installation based on the citizen request. Westbound vehicles on Los Pinos Vista did not yield at Yucca Via prior to completing their turning maneuver during the observation period.

Conclusion:

The intersection study determined a stop sign is recommended to be installed for westbound vehicles on Los Pinos Vista at Yucca Via. Stop control is recommended due to observed driver behaviors and sight distance limitations as a result of vegetation and the vertical profile of Yucca Via.

Recommendation:

The Pima County Department of Transportation recommends that a stop sign be installed for westbound Los Pinos Vista at Yucca Via based on the results of the intersection study in order to reduce potential vehicular conflicts.

ORDINANCE 2019 - _____

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, RELATING TO TRAFFIC AND HIGHWAYS; REGULATING TRAFFIC AT THE INTERSECTION OF LOS PINOS VISTA AND YUCCA VIA IN PIMA COUNTY, ARIZONA

THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA FINDS THAT:

1. The Board of Supervisors of Pima County, Arizona has authority under A.R.S. § 28-627 and 28-855 as amended, to designate and establish stop intersections and to erect stop signs.
2. The Board of Supervisors has determined that it is in the interest of public safety to establish the intersection of Los Pinos Vista and Yucca Via as a stop intersection in Pima County, Arizona.

BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA:

SECTION 1. The intersection of Los Pinos Vista and Yucca Via shall be designated a stop intersection with westbound traffic on Los Pinos Vista stopping for traffic on Yucca Via.

SECTION 2. All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take into effect when and to the extent that stop signs are posted on the intersecting streets.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
