Requested Board Meeting Date: January 22, 2019

Title: Fair Horse Racing Commission - County Fair Horse Racing- Single Date change request for 2019

Introduction/Background:

The Pima County Fair Horse Racing Commission (PCFHRC) requested race dates for the 2019 season which were approved by the Pima County Board of Supervisors during the November 6th meeting. Following that approval, the Pima County Fair Horse Racing Commission held their monthly December meeting and have requested to change the February 23rd approval date to the new date of March 2nd.

Discussion:

In order to allow horses to prepare for the County Fair Horse racing date and to allow the the date to include the promotion planned for March 2nd, the change was requested. Once approved by the Board the date change will go to the Arizona Department of Racing for approval.

Conclusion:

The change of date from February 23rd to March 2nd will not change the total number of racing dates but will accommodate the Horsemen and Commission.

Recommendation:

We recommend approval of the date change.

Fiscal Impact:

No change in revenue will be felt by the approval of the date change.
