RESOLUTION OF THE PIMA COUNTY BOARD OF SUPERVISORS PERMITTING THE TEMPORARY CLOSURE OF PORTIONS OF ANKLAM ROAD FROM DAYSTAR MOUNTAIN DRIVE TO SPEEDWAY BOULEVARD AND SPEEDWAY BOULEVARD FROM ANKLAM ROAD TO PAINTED HILLS ROAD IN PIMA COUNTY, ARIZONA, FOR THE TUCSON BICYCLE CLASSIC EVENT ON SUNDAY, MARCH 3, 2019.

## The Board of Supervisors of Pima County, Arizona finds:

- 1. Pima Velo is conducting an annual event on Sunday, March 3, 2019.
- 2. Pima Velo has requested the temporary closure of portions of Anklam Road from Daystar Mountain Drive to Speedway Boulevard and Speedway Boulevard from Anklam Road to Painted Hills Road from 5:00 A.M. to 3:00 P.M. to facilitate this event.
- 3. The Pima County Board of Supervisors has determined that it will be necessary to permit the temporary closure of portions of Anklam Road and Speedway Boulevard to support this event.

## NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. Portions of Anklam Road from Daystar Mountain Drive to Speedway Boulevard and Speedway Boulevard from Anklam Road to Painted Hills Road shall be temporarily closed to public traffic on Sunday, March 3, 2019 from 5:00 A.M. to 3:00 P.M.
- 2. All applicable County officers and employees are hereby authorized and directed to perform all acts necessary or desirable to give effect to this Resolution.
