

RESOLUTION OF THE PIMA COUNTY BOARD OF SUPERVISORS
OF TRANSPARENCY IN THE MEETINGS AND DELIBERATIONS OF
THE COMMUNITY LAW ENFORCEMENT PARTNERSHIP COMMISSION

WHEREAS, public safety must be the primary focus of Pima County Government, and

WHEREAS, the residents of Pima County should have adequate knowledge and understanding of efforts by Pima County Government to insure their general safety, and

WHEREAS, the Pima County Board of Supervisors created the Community Law Enforcement Partnership Commission to make recommendations to the Pima County Board of Supervisors regarding the appropriateness and justification of acceptance or rejection of various grants being made available to area law-enforcement agencies in general, and the Pima County Sheriff's Department in particular, and

WHEREAS, it is essential that transparency in government be pursued for the well-being and confidence of Pima County residents, and

WHEREAS, the Community Law Enforcement Partnership Commission's mission is to examine grants intended to be used as tools to secure public safety and the public has an inherent right to know the substance and purpose of said grants,

NOW, THEREFORE, BE IT RESOLVED that the Pima County Board of Supervisors directs the County Administrator to provide full and complete coverage of the Community Law Enforcement Partnership Commission's meetings and deliberations in the most transparent of methods available to Pima County Government, and

BE IT FURTHER RESOLVED that the Pima County Board of Supervisors additionally directs the County Administrator to provide a full spectrum of public access to the Community Law Enforcement Partnership's meetings and deliberations utilizing, but not limited to, the County's cable access channel, Internet streaming, and Facebook Live.


