Title: Resolution Authorizing Pima County to Condemn for the Twin Peaks Sewer Project

Introduction/Background:

Pima County Wastewater and Reclamation's Twin Peaks Sewer Project (the "Project") extends sewer service to a fast developing area. Permanent Easements and Temporary Construction Easements (TCE) are being acquired in order to construct and operate the new sewer facilities.

Discussion:

An offer has been presented to TRP Twin Peaks L.L.C. for the acquisition of an easement and TCE over a portion of its property for the Project. The property owner is interested in reaching an agreement but is prevented from providing clear title due to a property claim currently under appeal at the Arizona Supreme Court. To keep the project time line, Pima County must proceed with acquiring the Easements by condemnation.

Conclusion:

The Pima County Attorney will be authorized to institute condemnation proceedings to acquire real property interests from TRP Twin Peaks L.L.C. for the Project.

Recommendation:

Staff recommends approval of the attached Resolution authorizing condemantion.

Fiscal Impact:

The Permanent Easement has been appraised at \$48,544 and the TCE has been appraised at \$5,500 for a total appraised value of \$54,044. Property owner is not disputing the value.

Twin Peaks - TRP Condemnation

- 1. Pima County plans to construct and maintain sewer facilities, to serve a fast developing area along Twin Peaks Road as part of the Twin Peaks Sewer Augmentation Project (the "Project") located in Section 1 OF TOWNSHIP 12 SOUTH, RANGE 12 EAST, G&SRM, for the use and benefit of the public; and
- 2. The Board of Supervisors of Pima County finds it is necessary to exercise its powers of eminent domain, pursuant to A.R.S. § 12-1111, to acquire interests in the real property as described in attached **Exhibit A** and **Exhibit A-1** in order to construct the Project;

NOW, THEREFORE, BE IT RESOLVED that the Pima County Attorney be and is hereby authorized to institute condemnation proceedings to acquire real property interests necessary for the above described Project, from the real property shown on the attached **Exhibit A and Exhibit A-1**, in the event that the property interests cannot otherwise be acquired in a timely manner.

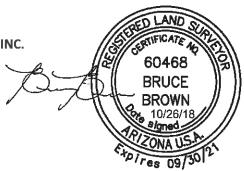

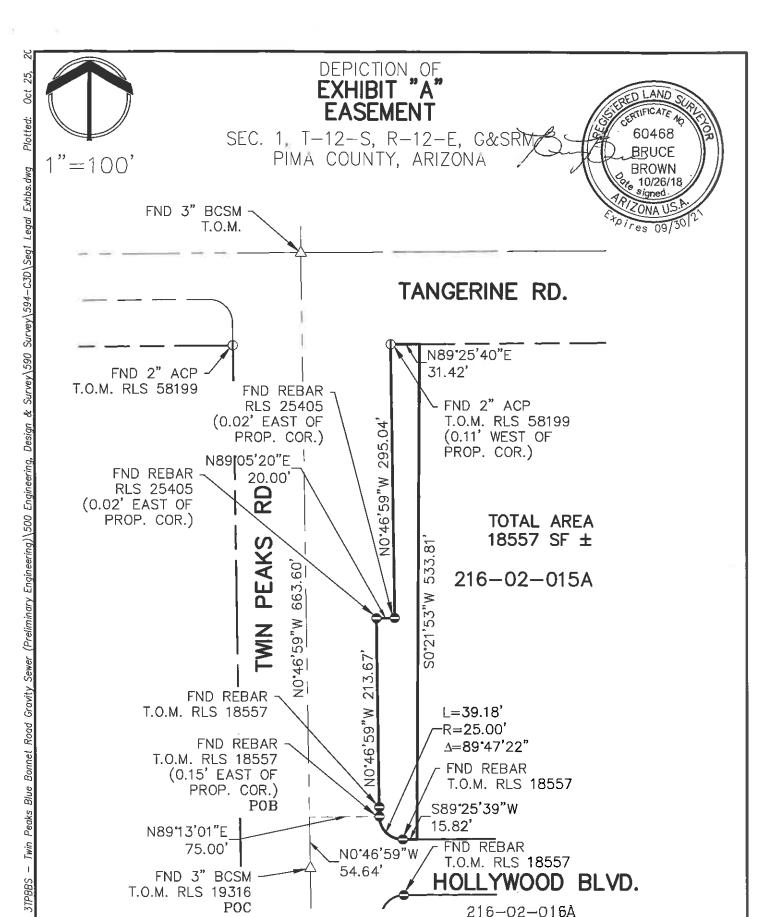
