WE have lived 7840 N Carolanne Dr. for 50+ years and have had flooding problems before the County under cut Massingale Rd and put in a retention basinat the Massingale /Camino de Oeste intersection, lowering property value on Massingale Rd. This cured 90 percent of our flooding until the development was done at the south side of Pima Farms

WE have had several floods when it rains, but never three (3) times in the same month (July, 2018). I piled a two foot bank at the back of my property to keep the water in the dedicated right of way which is also a drainage way. This fill was washed away on the first flooding due to the force of the water. We have never been flooded this bad until this development was built

In regards to the flood control, I called Mindy to look at the damage and she came out to see the neighbors trash that he piled in the drainage area and it is still there. I have been fenced out of this area due to the fence being put on my property line. I hope you will consider this problem in your decision along with transportation problems.

My wife and I have lived here for 35 years. During all these years, we have had occasional heavy rains.

We never experienced flooding until the subdivision on the Southwest corner of Pima Farms and Magee went in.

In the early eighties, Massingale was lowered and a retention basin was installed on the Northeast corner of Massingale and Camino De Oeste. This took care of the runoff from the subdivisions North of Camino De Oeste. This action was taken due to properties being flooded from runoff flowing west on Massingale. The flooded properties sued which prompted the remedial action.

Since the subdivision on the Southwest corner of Pima Farms and Magee went in, we have experienced multiple flooding episodes far worse than anything before.

One of my outbuildings has been ruined by repeated flooding.

It is obvious that the system the county approved to handle runoff from this subdivision is totally inadequate. We are definitely getting more water from the East of our property than we ever had before. The contractor probably built the system according to the approved specs so the fault lies squarely on the County for approving the inadequate system.

Let us hope the County tales responsibility and prevents the necessity of litigation in this matter.
