Re: Conditions for Accepting Operation Stonegarden (OPSG) Grant for FFY 2018

As you know very well, I stand firmly opposed to accepting the Stonegarden grant under any circumstances. Nothing has changed since the Board canceled the grant last year. The strings attached to accepting the grant are just as onerous and just as detrimental to public safety and to effective, trustworthy community law enforcement.

However, if this Board is determined to accept the grant this year, I urge you to include the following binding conditions.

- 1. Until the Board of Supervisors (BoS) votes to say that **all** of the conditions have been met, no funds will be disbursed to the Pima County Sheriff's Department (PCSD), and PCSD isn't authorized to spend any money that would later be reimbursed from OPSG funds. No other spending that would later be reimbursed from OPSG funds is authorized either.
- 2. Allocate all of indirect cost recovery amount to county healthcare expense reimbursement and local NGOs working with refugees, as specified in Administrator Huckelberry's memorandum "Federal Fiscal Year 2018 Operation Stonegarden Grant Award in the Amount of \$1,155,866 (Overtime & Fringe Benefits) \$595,600 (Equipment) \$13,120 (Travel) and \$50,000 (Mileage) for a Total Grant Award of \$1,814,586" dated May 7, 2019.
- 3. Reallocate 50% of OT + Fringe, or \$577,933, to humanitarian purposes as allowed in the Consolidated Appropriations Act, 2019, Division F, Title III, Section 305 (§305) and in the FEMA Grant Programs Directorate Information Bulletin No. 436, November 27, 2018 (IB 436). New OT + Fringe = \$577,933. "Humanitarian purposes" is defined in §305 as "related to providing humanitarian relief to unaccompanied alien children and alien adults accompanied by an alien minor where they are encountered after entering the United States." Further guidance in IB 436 says "any costs associated with the immediate care or transportation of unaccompanied children and families are allowable. These allowable costs include costs for food, water, hygiene products, medicine, medical supplies and temporary housing, as well as costs for transportation to and from temporary housing or to permanent housing."
- 4. Reallocate 100% of LPR purchase price, or \$33,600, to humanitarian purposes. No LPRs will be purchased.

5. Total reallocation to humanitarian purposes under §305 and IB 436: \$611,533 – 33.7% of the total. The rest of the approved grant, amounting to \$1,203,053, remains allocated as specified in the approval letter, except that its allowable use may be changed when the Operations Orders are amended as specified in (6), below.

- 6. County Administrator and PCSD will collaborate to draft an amendment to the original Operations Orders, with details of how the funds will be used, including revised mileage (which may free up additional funds for humanitarian purposes) and including details of humanitarian expenses to which that portion will apply. Amendment will include a mandate to end all pretextual traffic stops and a mandate to end the policy of saturating an area and conducting zero-tolerance traffic stops.
- 7. The BoS must approve the amendment to the Operations Orders. If not, that triggers automatic rejection of the entire grant.
- 8. Submit the amendment to the Arizona Department of Homeland Security (AZDOHS). If they fail to approve within 60 days, that triggers automatic rejection of the entire grant.
- 9. As specified in IB 436, work with AZDOHS to submit the amendment to the US Border Patrol sector, US Border Patrol Headquarters, and FEMA Grant Programs Directorate. If they do not all approve the amended Operations Orders, that triggers automatic rejection of the whole grant.
- 10. After 7, 8, and 9 are met, the BoS must vote again before the funds can be disbursed to PCSD or to any other agencies (in the case of the humanitarian portion). They can still reject the whole grant at this point without any funds having been spent. (This allows for any tinkering to the Operations Orders that may happen in 8 or 9.)
- 11. The Pima County Sheriff agrees to stop cross-deputizing any federal agents and (if possible) to rescind all previous cross-deputizations. If it is discovered that the sheriff continues cross-deputizing or (if previous deputizations are rescinded) that federal agents continue to operate as if they were certified PCSD deputies, the PCSD portion of OPSG is cancelled effective immediately and the unspent remainder of OPSG funds assigned to PCSD are forfeit to AZDOHS.
- 12. The Sheriff agrees to terminate with written notice to ICE the Memorandum of Understanding between ICE and PCSD dated February 25, 2008, and the 2014 Memorandum of Agreement, authorizing PCSD personnel to identify and process immigration violators under section 287(g) of the Immigration and Nationality Act.
- 13. The County Administrator and the BoS agree to reassign Spencer Graves to work with the Community Law Enforcement Partnership Commission (CLEPC), to assign a staff person to observe PCSD, and to reposition the CLEPC under the Grants Management and Innovation department (GMI).

14. The Sheriff agrees to comply promptly and fully with data requests from the CLEPC. "Promptly" is defined as within 10 working days. "Fully" is defined as to the satisfaction of the CLEPC and the GMI. If PCSD ever fails to fulfill these conditions, that triggers automatic freezing of all OPSG funds assigned to PCSD. If the situation is not remedied within another 10 working days, the PCSD portion of OPSG is cancelled effective immediately and the unspent remainder of OPSG funds assigned to PCSD are forfeit to AZDOHS.

- 15. The Sheriff agrees that he is a member of the CLEPC *ex officio* and will make best efforts to attend all commission meetings.
- 16. The Sheriff agrees to respond promptly and candidly to OPSG questions from the CLEPC, including but not limited to questions about OPSG operations details and policies. "Promptly" is defined as within 10 working days. "Candidly" is defined as to the satisfaction of the CLEPC and the GMI. If the sheriff ever fails to fulfill these conditions, the PCSD portion of OPSG is cancelled effective immediately and the unspent remainder of OPSG funds assigned to PCSD are forfeit to AZDOHS.
