I am writing today with a sense of great urgency and personal concern about the candidacy of Jeremey Lasher.

In my role as a volunteer for the Democratic Party and also as Chair of Pima Dems, I have had numerous interactions with Mr. Lasher over the past five years. None of them have been pleasant or productive.

Mr. Lasher never addressed me personally about any issues he had with me; even when I would ask him, directly and in private, about his concerns. Instead I would hear from others about his displeasure. I encourage his potential employer to do a thorough review of his social media postings. (I am frustrated that I erased the comments Mr. Lasher has written about me, but I needed to do so in order to maintain calm in my life.)

Disagreements are a part of life. High anxiety and tensions are a part of life. In my dealings with Mr. Lasher I feel strongly he has no skill level to handle any of these situations with diplomacy or maturity.

In my opinion, it would be a terrible disservice to the people of Tucson to give Mr. Lasher a job that requires even minimal interaction with the public.
