This letter is in regards to the Barnyard Crafthouse and Eatery.

Our family is located at: 10995 E.Tanque Verde Rd.

My husband and I bought this home to raise our three young children. Our property is directly to the West of the restaurant and runs the entire length of the property. The side of our home which faces the restaurant is where our kids bedrooms/windows are, our back yard faces and it's the side of the house that we park our vehicles.

I'll start out by saying that our concerns with the restaurant have only grown with the growth and scale of the restaurant. I was present at the meeting at the library and while I was optimistic, we did have concerns. I was concerned about privacy, the mention of using an outdoor smoker and the noise a restaurant next door would generate, which I did bring up during the discussions. I left with a brochure & drawings of layout, notes from the discussion and the impression that this was intended to be a "quaint, quiet, in the country" café. To be serving breakfast on the weekends and lunch/dinner during week. This was, we felt very reasonable and appropriate for the area.

The biggest change from then and now is without a doubt, the scale. The scale of the Barnyard has increased immensely. Whether this is due to permit changes or parking issues I don't know. But I do know that this is no longer and small cute neighborhood café that's is the country. This is a full scale, large, loud intrusive bar and grill that has again grown significantly and expand their footprint after reviewing the site and documents.

The new proposed parking lot extension would run the length of our property and is highly concerning. Privacy is of huge importance for us. Currently they have a chain link fence that provides zero privacy or much security from the many people who will be coming in going in the parking lot. Headlights would shine into our yard for hours on end coming and going in the evening. Patrons who have had too much to drink loitering in the parking lot. Again, the noise from the restaurant itself and any music playing can be easily heard. We would request that some kind of a barrier/fence be installed. Wall...fence...metal something significant to block the line of site. I don't want to see and hear the restaurant constantly nor do I want hundreds of people looking into my yard or my kids playing, etc. A fence would be a huge relief.

The new proposed outdoor kitchen is also to West. We have concern as to the smoker. It was mentioned onsite the smoker would run overnight as well as during the day. Smoked meats take time and we will be smelling this 24/7. At 5am when we sit on our beautiful back porch, all day, every night. We already will have to get used to a full kitchen running and the grease stacks, etc. But a smoker running constantly is daunting

The new bandstand structure for the band also faces West and is a big concern as well as outside tvs. Sound travels effortlessly out here in this quiet rural area. I'm nervous the band will be excessively so loud and intensified by being up above the ground. This will negatively affect our quality of life. We have to wake up early for work during the week....enjoy our quiet mornings....kids going to bed all will absolutely be effected my a live band.

Overall the entire scale is significantly more on multiple levels. The new built kitchen isn't enough, now they want an outdoor kitchen. The seating was reasonable and now is 50+ tables. The parking lot size has nearly tripled. The hours of operation started small and now is 8am-10:30pm seven days a week and with playing the sport games and serving alcohol will most definitely run past like every other place in town.
