This letter regards case number: P19CU0005. I would like to express my opposition to this case, or the plan to develop a 19.26-acre "bike ranch" across from the Saguaro National Park east. For over 27 years, my family has lived within the 300-foot notification area of the proposed development site. I am strongly opposed to this plan and ask that you vote "no" on the request for Type II Conditional Use Permit For a Minor Resort in the SR Zone located at 3700 South Old Spanish Trail.

Commercial development should not be permitted so close to a national park—allowing this encroachment will set a dangerous precedent for other national parks. Sites like the Saguaro National Park east and its surrounding desert land are rare, irreplaceable, and offer unique natural peace to its residents and visitors. Bulldozing almost 20 acres of thriving, natural desert is an irreversible and ecologically harmful plan.

The bike ranch, which anticipates 33 buildings and a capacity of over 260 people, will bring increased volumes of traffic, noise, sewage, trash, crime and pollution. These factors threaten the well-being of the wildlife and biodiversity of the park and its surrounding area, and significantly diminish the natural serenity and aesthetic beauty of this environment.


We, the undersigned, own property within the Buffer Zone and the SR zone!

We live less than one mile from the entrance of Saguaro National Monument and are extremely concerned with the potential increase in traffic in an already congested and dangerous intersection (Escalante & Old Spanish Trail). The Bike Ranch/Motel will only increase traffic from vehicles and bicvcles. There is a reason for the buffer Zone and we don't want this buffer zone to be removed nor modified.

We purchased our property with the understanding that the surrounding area is zoned SR Suburban Ranch, requiring a minimum lot area of 144,000 sf (3.31 ac) per lot. A conditional variance (SR exception) for this development would significantly increase building density and population. PHASE 1 has the potential for up to 200+ guests and 60 employees on this property and in the surrounding areas. It is no longer a "minor resort". It has the essence of a mid-size travel lodge which will contribute to greater traffic congestion, noise/light pollution as well as disturb the desert eco-system.
