Title: "Canada Day in Pima County" Proclamation

## Introduction/Background:

The Pima County Economic Development Office works closely with the non-profit Canada-Arizona Business Council to promote Canadian business attraction, tourism and foreign direct investment in Pima County. This proclamation is intended to strengthen Pima County's relationship with Canada and the Canada-Arizona Business Council in furtherance of the County's economic development activities and goals.

#### Discussion:

Pima County has seen an increase in both Canadian companies arriving in Pima County and Canadian foreign direct investment - primarily in the area of merger and acquisition. Canada remains a trusted trade partner that has created approximately 146,800 jobs in Arizona within a bilateral trade and service footprint of \$3.6 billion annually. Approximately 400 Canadian companies operate in Arizona including some of Pima County's largest employers, such as Bombardier and Fortis/Tucson Electric Power. An estimated 150 Arizona companies operate in Canada and Canada is the largest provider of foreign direct investment in the state. Close to 1 million Canadians tourists visited Arizona last year spending more than \$1 billion.

#### Conclusion:

In recognition of the important economic relationship between Canada and Pima County, it is fitting to acknowledge and strengthen our bonds.

#### Recommendation:

Noting the important economic relationship that exists between Pima County and Canada on the upcoming anniversary of the country's confederation, it is fitting to present a proclamation to the Honorary Consul of Canada in Arizona and the Canada-Arizona Business Council proclaiming July 1, 2019 as "Canada Day in Pima County."
