CONTRACT AMENDMENT

- **1. Background.** The parties acknowledge that the following information is accurate:
 - 1.1. On April 7, 2009, Ajo Country Club fka Ajo Community Golf Course ("Contractor") entered into the above referenced Cooperative Agreement to provide management, operations, and maintenance of the Ajo Community Golf Course.
 - 1.2. The original agreement term commenced on April 7, 2009 and ended on June 30, 2014. The parties amended the original term of the agreement effective July 1, 2014 changing the end date to June 30, 2019.
 - 1.3. The parties want to extend the Term of the Contract on a month-to-month basis not to exceed four (4) months or until a new Operating Agreement has been executed, whichever occurs first.
- **2. Term.** The Contract will renew on a month-to-month basis commencing on July 1, 2019 and will terminate no later than October 31, 2019.

The effective date of this Amendment is June 30, 2019.

All other provisions of the Contract not specifically changed by this Amendment remain in effect and are binding upon the Parties.
