***Project Title/Description:**

Arthur Pack Regional Park First Amendment to License Agreement

***Purpose:**

The First Amendment to License Agreement ("First Amendment") will extend the term of the License Agreement (the "License") with District for an additional term of five (5) years, effective as of July 1, 2019, and terminating on June 30, 2024. The License permits and regulates the District's use of a portion of the parking lot (the "Parking Area") at County's Arthur Pack Regional Park, as well as the access road which links the Parking Area to Linda Vista Road. Wildcat Golf Partners, an original party to the subject License, will no longer be a party to this License as of the Effective Date. Lic-0303.

***Procurement Method:**

Exempt pursuant to Pima County Code 11.04.020.

***Program Goals/Predicted Outcomes:**

District will complete certain improvements to the Parking Area and access road at its sole expense and to County's satisfaction, as of the deadlines set forth in Sections 11 and 12 of the First Amendment. In addition, District will reimburse County for 38% of County's cost of repairing and maintaining the entrance road and Parking Area, as set forth in Section 13 of the First Amendment. The estimated amount of District's share is \$30,000

***Public Benefit:**

Public access road and the Parking Area will be maintained by County and District, for the benefit of users of Arthur Pack Regional Park and students and teachers at Mountain View High School.

***Metrics Available to Measure Performance:**

Work performed timely and satisfactorily by District, and District's timely reimbursement of its share of County expenses.

***Retroactive:**

Yes. Retroactive to July 1, 2019. District's Board will not convene to approve and execute until August, 2019.

FIRST AMENDMENT TO LICENSE AGREEMENT

1. Background and Purpose.

2. On July 1, 2014, COUNTY entered into a License Agreement (the "**License**") with Marana Unified School District ("**District**") and Wildcat Golf Partners, LLC, as Lessee of the Crooked Tree Golf Course, pursuant to which County permitted District to use specific portions of the parking lot at the County-owned Arthur Pack Regional Park, located at 9101 N. Thornydale Road, Tucson, AZ 85742, (the "**Parking Area**") as well as the access road that links the Parking Area to Linda Vista Road (the "**Access Road**").
3. The License will expire on June 30, 2019.
4. The License provides in Section 1 thereof, that the term of the License could be extended upon request by District, and at the sole discretion of the County.
5. District has requested and County has agreed to extend the term of the License for a five (5) year period, effective as of July 1, 2019; and
6. District has agreed to perform certain repairs to the Parking Area during certain time frames.
7. Wildcat's agreement with County acknowledges the existence and potential extension of a license for MUSD to use the Parking Area and Access Road, and it is not a necessary party to this License.

8. Upon execution by District and the Pima County Board of Supervisors, the effective date of this First Amendment shall be retroactive to July 1, 2019 (the “**Effective Date**”).
9. The term of the License is hereby extended to June 30, 2024.
10. Wildcat Golf Partners will no longer be a party to this License as of the Effective Date.
11. On or before June 30, 2019, District shall complete, at its sole expense and to the County’s satisfaction, a seal coat and stripe of the main entrance road from Thornydale Road to the entrance of the golf course/student parking area that is currently used by District busses as ingress/egress. After District performs this asphalt maintenance, the expense of all future repairs/improvements will be shared between both COUNTY and District as provided in Section 13 below.
12. On or before June 30, 2020, District shall complete, at its sole expense and to the County’s satisfaction, a mill and fill of the Access Road. During the term of this License, District will maintain the Access Road at its own expense.
13. Except for the seal coat and striping of the entrance road as set forth in Section 11, County will repair and maintain the Parking Area and the entrance road during the term of this License, but not the Access Road, which is District’s responsibility. District will reimburse County for 38% of the County’s cost of repairing and maintaining the entrance road and Parking Area. The estimated amount of District’s share is \$30,000.
14. All other terms and provisions of the License not specifically changed by this First Amendment shall remain in effect and are binding upon the Parties.
