
Please do NOT grant a conditional user permit for the Bike Ranch Motel that is purposed on Old Spanish Trail across from Saguaro National Park East. <u>Case P19CU00005</u>

My husband, sons, and I live at 11835 E Calle Aurora across from Saguaro National Park off of Freeman Road. We are not fans of the cyclist packs that frequent Freeman Road and we are not fans of the traffic that has increased on Freeman road, due to all the new construction in Vail. The combination of these two is bound to lead to catastrophe. Many commuters use Freeman/Old Spanish Trail to access mid-town Tucson and many cyclists use Freeman/Old Spanish Trail. The cars are frequently exceeding the speed limit and the cyclists are frequently disobeying laws, such as stop signs and riding more than 3 abreast over blind hills. We do not want to see MORE cyclists introduced to the area, we would like to see less. And we don't not want to add more traffic to an already congested area.

Dear Supervisors:

I oppose the proposed Bike Ranch across from the entrance to Saguaro National Park. My wife and I have been residents of this neighborhood for 30 years. In addition to being a concerned Park neighbor I speak as a PhD scientist that worked with National Park Service issues for 3 decades. In 1973 I began as a member, of the Western Regional Advisory Committee, a western U.S. group that served as consultants to the National Park Service on management and science issues. From 1974 to 1992 I was a National Park Service Research Scientist. During that time I was involved in numerous research projects that studied impacts of various activities on Park resources and how factors such as crowding affected the Park visitors' experience. Old Spanish Trail in the vicinity of Saguaro National Park headquarters is already a dangerous road with bimonthly vehicle mishaps (see attached table) including at least 1 fatality at the corner of Old Spanish Trail and Freeman Road.

Allowing the construction of the proposed Bike Ranch across from the entrance to Saguaro National Park would increase CONGESTION in the area, thus increasing the probability of a vehicle collision with a bike or horse, possibility causing serious injury or death to a bicyclist or equestrian and/or to a vehicle occupant. Knowing of this congestion in advance and ignoring warnings of liability increases the legal liability of the Bike Ranch and perhaps any governmental agency approving its construction.

A "CONGESTED AREA" standard highway sign has already been placed on Old Spanish Trail 0.1 mile south of the Park entrance. Also, when approaching the Park entrance from the north on Old Spanish Trail there are numerous highway warning signs declaring: "CURVES AHEAD," "WATCH FOR ANIMALS," an equestrian sign, and speed limit signs.

The proposed Bike Ranch would be in the midst of a 0.4 mile stretch of Old Spanish Trail (OST) that already has 8 entrance/exit points onto OST:

1.2 Major intersections

- (A) OST and Escalante Rd. to the south
- (B) OST and Freeman Rd. to the north
- 2. 1 Minor intersection

(A) OST and Pantano Trail

3. 5 Entrances to OST from local establishments

(A) Saguaro National Park, directly across from a proposed Bike Ranch entrance

(B) Saguaro Corners restaurant

(C) 2 Private residences

(D) Driveway to a series of houses rented by the previous owners

The proposed Bike Ranch would also have 2 entrances and even though the entrance directly across from the Park entrance might be chained and for emergency vehicles, etc., bicyclists would have no trouble bypassing that chain, directly into Old Spanish Trail traffic.

In 2014, approval for the proposed Bike Ranch was blocked by then County Supervisor Ray Carrol, Park Superintendent Darla Sidles and Assistant, Scott Stonum. We have been told that since 2014 the Bike Ranch developers have made modifications to their original plan in order to make it more palatable. Alternatively, we would suggest that the developers instead (1) waited until there had been a turn-over of the County Supervisor as well as both Park Administrators in an attempt to do an end run and seek approval for their plan and (2) found a way to make their venture more profitable. There has been only one meeting between developers of the proposed Bike Ranch and Park neighbors, and then not until toward the end of the planning process. In addition, I have worked closely with leaders of Save Saguaro National Park, met with Park Administrators, and have been involved in several neighborhood meetings about the proposed Bike Ranch. I have yet to hear of a single person that has been contacted and asked for input by either Bike Ranch developers or Saguaro National Park administrators.

In the meantime, Bike Ranch developers have received a report, dated February 25, 2019, from the engineering firm, Psomas, This report is entitled "an evaluation of traffic conditions associated with the proposed Bike Ranch Resort." What is perhaps more interesting about that report is what it does not say rather than what it does say. For example, in the "smoke and mirrors" of this report the term CONGESTION is never used despite the "CONGESTED AREA" highway sign on OST where the Bike Ranch is proposed and located just a couple of hundred yards south of the Park entrance. Nor does the report mention the numerous highway signs immediately north of the Park entrance that warn of things such as horses and riders, and curves ahead. That report also has an online reference to a regional bike map that shows Old Spanish Trial north of the Park as a SHARED USE bike path. That is because that section of Old Spanish Trial (OST) is shared by bikes, horses and riders, cars, trucks pulling trailers, and hikers, all approaching the Park from the north, adding to the congestion of that section of OST. In addition, within a distance of 0.2 of a mile there are:

1. A sharp curve on OST

2. The Park entrance

3. The major intersection of OST with Freeman Rd.

4. The intersection of Pantano Trail with OST

5. The entrances to 2 residences

So, you can understand why we're skeptical when the engineering report done for the Bike Ranch suggests that everything should be hunky dory with the Bike Ranch being plopped down on top of all of this congestion and that no traffic problems are expected to be associated with development of the Bike Ranch. I would term it differently—**as an accident waiting to happen.**

As a resident of the area and a retired National Park Service Research Scientist I request that you not approve the proposed Bike Ranch. Thank you for the opportunity to present my views on the subject.

Dear Chair Elias, Supervisors and staff

The Tucson Audubon Society, National Parks Conservation Association and myself appreciated the opportunity to meet with MJM Consulting (Michael Marks) and an owner/developer of the proposed Bike Ranch, Kelly Matthews, on June 18th, at Mr. Marks request. We had a cordial meeting where we were informed of the desire of the developer to make this a net-zero example of sustainable development that would not only comply with, but also exceed the expectations of the Pima County Buffer Overlay Zone Ordinance (BOZO). We applaud this goal and incorporate the Bike Ranch LLC Program for Sustainability by reference.

Though there seemed to be no opportunity to address any changes in the configuration of the proposed development plan, nor any willingness to include discussion of the adjacent parcel to the south of the parcel in question and it's future development, which will actually be contiguous with the proposed Bike Ranch, we appreciated the opportunity to express our concerns. Though Ms. Matthews was not amenable to any further delay of the upcoming hearing, we wish to reiterate our willingness to work together to exceed the basic BOZO requirements and contribute to the creation of a model project.

Mr. Marks offered a few additional special conditions the developer would entertain and we adjourned to consider same. Below, please find special conditions we would suggest might be appropriate for consideration, subject to staff review for conformity.

ADDITIONAL SPECIAL CONDITIONS REQUESTED, if approved

- The owner/operators of the Bike Ranch shall maintain an open, collaborative and cooperative communication program with Saguaro National Park (SNP) administration/staff during all planning, permitting, construction, and operational stages of the Bike Ranch. This agreement shall be formalized and shall be recorded as a covenant, to run with the parcel(s) in perpetuity.
- 2. The design, construction and operation of the parking lot, driveway, all structures, walkways, and other common areas, including swimming pool and seating areas, and any disturbed lands shall implement 1) measures to reduce the heat-island effect including the use of permeable pavement alternatives, pergolas and lattice structures to support vines, trees, and solar panels, or a combination thereof for shading, 2) measures for the use of water harvesting throughout the site, from buildings, permaculture techniques, low impact

design and other green infrastructure, etc., 3) enhanced vegetative and/or other visual screening to mitigate the visual impact on Saguaro National Park, both from the entrance and from heights within the Park, and 4) enhanced vegetative and water harvesting features to support suitable habitat for resident and migratory birds, other pollinators such as butterflies, moths and bats, herps, small mammals and other wildlife and provide permeability for wildlife.

- 3. The owners/developers/operators of the Bike Ranch shall consult with the Tucson Audubon Society (TAS) during the design, planning, construction and operational phases, at minimum prior to groundbreaking, during surface disturbance and construction activities, and post-construction, and at 6 months intervals thereafter to monitor vegetation development and implementation of permaculture principles, and for input on matters raised by that organization in the letter it wrote to the Pima County Board of Supervisors May 17, 2019, such as the following point.
- 4. The owners/operators indicated the intention to seek LEED Platinum certification for all construction. We encourage and applaud this standard, and would request the inclusion of the LEED Pilot Credit #55 Reducing Bird Collisions. Building 'bird friendly' is compatible with the LEED system, especially when included in construction planning from the beginning.
- 5. The owners/operators shall reestablish and restore all existent drainages (minor washes) on the property post construction utilizing permaculture techniques to slow flow and establish suitable vegetation, wildlife habitat and wildlife permeability values.
- 6. Roof colors shall comply with or exceed the Buffer Overlay Zone (BOZO) restrictions found in Zoning Code Section 18.67.050.C. Additionally, any roof coating material used shall be colored tan or grey or light green or a combination thereof, whichever is deemed best for visual screening from the Park, in consultation with the SNP administration/staff and TAS.
- 7. All graded or otherwise disturbed but not built on land shall be revegetated with plants on the BOZO Plant List, at minimum, and may be augmented, based on elevation, soils, and microhabitat characteristics, to provide groundcover, mid-story and canopy suitable for the site to enhance habitat and permeability for birds and other pollinators, herps, small mammals and other wildlife, subject to the prior approval of the planning director or authorized county representative.
- 8. All exterior lighting fixtures shall be shielded at the top and sides so as to provide for the minimum requirements for public safety while at the same time not be more visible than necessary from beyond the property to minimize light pollution to the maximum extent practicable, even if this exceeds current BOZO requirements. That could include

incorporating red lights, such as those used on Kitt Peak at night, to minimize impacts.

- 9. No erosion hazard setback variances shall be sought or granted.
- 10. Exterior paint of any structures shall be chosen so as to minimize visibility from all aspects of SNP, even if this exceeds the requirements of the BOZO.
- 11. A conservation easement shall be placed on all natural, undisturbed open space pre ground disturbance and shall be expanded to include all restored functional open space post construction, that shall allow vegetation planting, irrigation (if appropriate) and maintenance but shall preclude any other future disturbance or development, pursuant to Arizona Revised Statutes Section 33-271, et seq.
- 12. As the Bike Ranch is a multistory structure, all interior lighting shall be shielded/screened between sunset and sunrise, to the maximum extent practicable, from SNP at night, to maintain Dark Sky goals, even if this exceeds the BOZO requirements.

Because of the close proximity to the park, the proposed Bike Ranch, while not expecting to cause harm or damage to the natural beauty of the park, would disguise its view, diminish its peaceful setting and infringe on the environment that exists today. There are many places to build a Bike Ranch, but this park is fixed in its existence and is there to provide peace and beauty to the residents of Tucson. I kindly ask that you reconsider the placement of a Bike Ranch in another location. As a visitor to Tucson, I would be disheartened to see this development take place near Saguaro National Park.
