My name is Elizabeth Laughlin. This past June 24th I wrote a protest letter for a liquor license applicant located next door to me. (10088 N. Saint Patrick Rd. Tucson, AZ 85742).

Since the time of that writing, the owner (Mr. Roger Pelton) has visited my house (June 28th) to discuss the protest letter I wrote to the Board of Supervisors.

Mr. Pelton & I spoke of my concerns about his potential alcohol business being next door to me. We discussed ways items could be addressed (including communication on matters that arise, in addition to his potential alcohol business next door <u>not becoming a public wine tasting room</u>.) I wrote to you with my concerns of having a potential alcohol business next door to me on June 24th. The Liquor license applicant at 10088 N. St Patrick Rd Tucson, AZ 85742, (Mr, Roger Pelton). Since the time of writing, the following has transpired, and I am withdrawing my protest on the applicant:

Roger Pelton came to my house Friday, June 28 to share his current wine intentions, hopes, and statements about the house next door to me that he owns; following up via phone call later that afternoon. Attached is a signed statement from Roger that has helped alleviate my concerns, along with some of the discussion:

1) Roger states that he will not have a wine tasting room open to the public. (signed statement by Roger attached).

(This addresses the concern of potential drunk drivers on our neighborhood single lane dirt road - concern #2 of the June 24th letter).

2) Roger has stated that the potential liquor license for this address if issued will not be transferable.

This helps alleviate my property value concern. (concern #1 in my June 24 letter). - Roger has stated that he wishes to upkeep and run his wine production facility with respect to what is a surrounding neighborhood.
