Title: Eagle Cove Drive and Freedom Eagle Drive Yield Ordinance

Introduction/Background:

The Pima County Department of Transportation received a citizen request to install traffic control signage at the four-legged intersection of Eagle Cove Drive and Freedom Eagle Drive. Eagle Cove Drive and Freedom Eagle Drive are both local reading. Eagle Drive are both local roadways with a posted speed limit of 25 mph.

Discussion:

The Pima County Department of Transportation conducted a study at the intersection of Eagle Cove Drive and Freedom Eagle Drive based on the citizen request.

Conclusion:

The study determined that yield signs are recommended to be installed for the northbound and southbound intersection approaches to assign right of way at the four-legged intersection. No sight visibility restrictions were observed.

Recommendation:

The Pima County Department of Transportation recommends that the intersection of Eagle Cove Drive and Freedom Eagle Drive be designated a yield intersection with traffic on Eagle Cove Drive yielding right of way to traffic on Freedom Eagle Drive.

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, RELATING TO TRAFFIC AND HIGHWAYS; REGULATING TRAFFIC AT THE INTERSECTION OF EAGLE COVE DRIVE AND FREEDOM EAGLE DRIVE IN PIMA COUNTY, ARIZONA

THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA FINDS THAT:

- 1. The Board of Supervisors of Pima County, Arizona has authority under A.R.S. § 28-627 and 28-855 as amended, to designate and establish yield intersections and to erect yield signs.
- 2. The Board of Supervisors has determined that it is necessary for the protection and convenience of the traveling public of Pima County, Arizona, to establish the intersection of Eagle Cove Drive and Freedom Eagle Drive as a yield intersection.

BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA:

SECTION 1. The intersection of Eagle Cove Drive and Freedom Eagle Drive be designated a yield intersection with traffic on Eagle Cove Drive yielding right of way to traffic on Freedom Eagle Drive.

SECTION 2. This ordinance shall take effect when and to the extent that yield signs are posted on the intersecting streets.

SECTION 3. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 4. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
