Title: Establishment of Tournament Way under Road Proceeding No. 3031.

Introduction/Background:

Seeking approval by the Board of Supervisors to accept the Establishment of Tournament Way under Road Proceeding No. 3031. Tournament Way is a new roadway.

Discussion:

The purpose of Road Proceeding No. 3031 is to accurately establish the new alignment of Tournament Way. This Establishment would accept the new right-of-way for this road into the Pima County Highway System.

Permission was granted by the Board of Supervisors to advertise the Establishment of this road at the September 17, 2019 Board Hearing.

Conclusion:

If Approved:

The Department will accept the Establishment of the new right-of-way for Tournament Way into the Pima County Highway System.

If Denied:

The Department will not pursue the Establishment of Tournament Way and there will not be a clear delineation of the right-of-way for this road.

Recommendation:

The Department of Transportation recommends that the Board of Supervisors approve the Establishment of this County Road under Road Proceeding No. 3031.

Fiscal Impact:

Funding for future maintenance on new roadway would come from Operating Funds.

RESOLUTION AND ORDER NO. 2019- _____

A RESOLUTION AND ORDER OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, PROVIDING FOR THE ESTABLISHMENT OF TOURNAMENT WAY, A COUNTY HIGHWAY SITUATED WITHIN SECTION 32, TOWNSHIP 14 SOUTH, RANGE 14 EAST, GILA AND SALT RIVER MERIDIAN, PIMA COUNTY, ARIZONA.

UNDER PROCEEDING NO. 3031

The Board of Supervisors of Pima County Arizona finds:

1. The County Engineer has requested that the Pima County Board of Supervisors establish a county highway to be known as Tournament Way, located within a portion of Section 32, Township 14 South, Range 14 East, Pima County, Arizona, pursuant to Arizona Revised Statutes (A.R.S.) Section 28-6701(B), said road being more fully described in attached Exhibit "A".
2. The County Engineer filed a report and map of the proposed highway with the Board in accordance with A.R.S. § 28-6702(A)(1).
3. Said petition for establishment was set for a hearing before the Board on October 1, 2019, in accordance with A.R.S. § 28-6703.
4. Notice of the hearing was published once a week for two consecutive weeks in a newspaper of general circulation prior to the hearing,
5. At the hearing on the 1st day of October 2019, the Board considered the feasibility, advantages and necessity of the highway sought to be established and determined the proposed highway to be a public necessity.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Board hereby establishes the public roadway described in the attached Exhibit "A" and commonly referred to as Tournament Way as a county highway.
2. The Clerk of the Board is hereby directed to record this Resolution and Order, together with a map of said highway, as Establishment Proceeding No. 3031 in the Office of the Pima County Recorder, Pima County, Arizona.
3. The appropriate County officers and employees are hereby authorized and directed to perform all acts necessary and desirable to give effect to this Resolution.

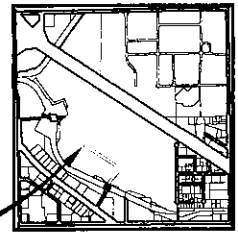

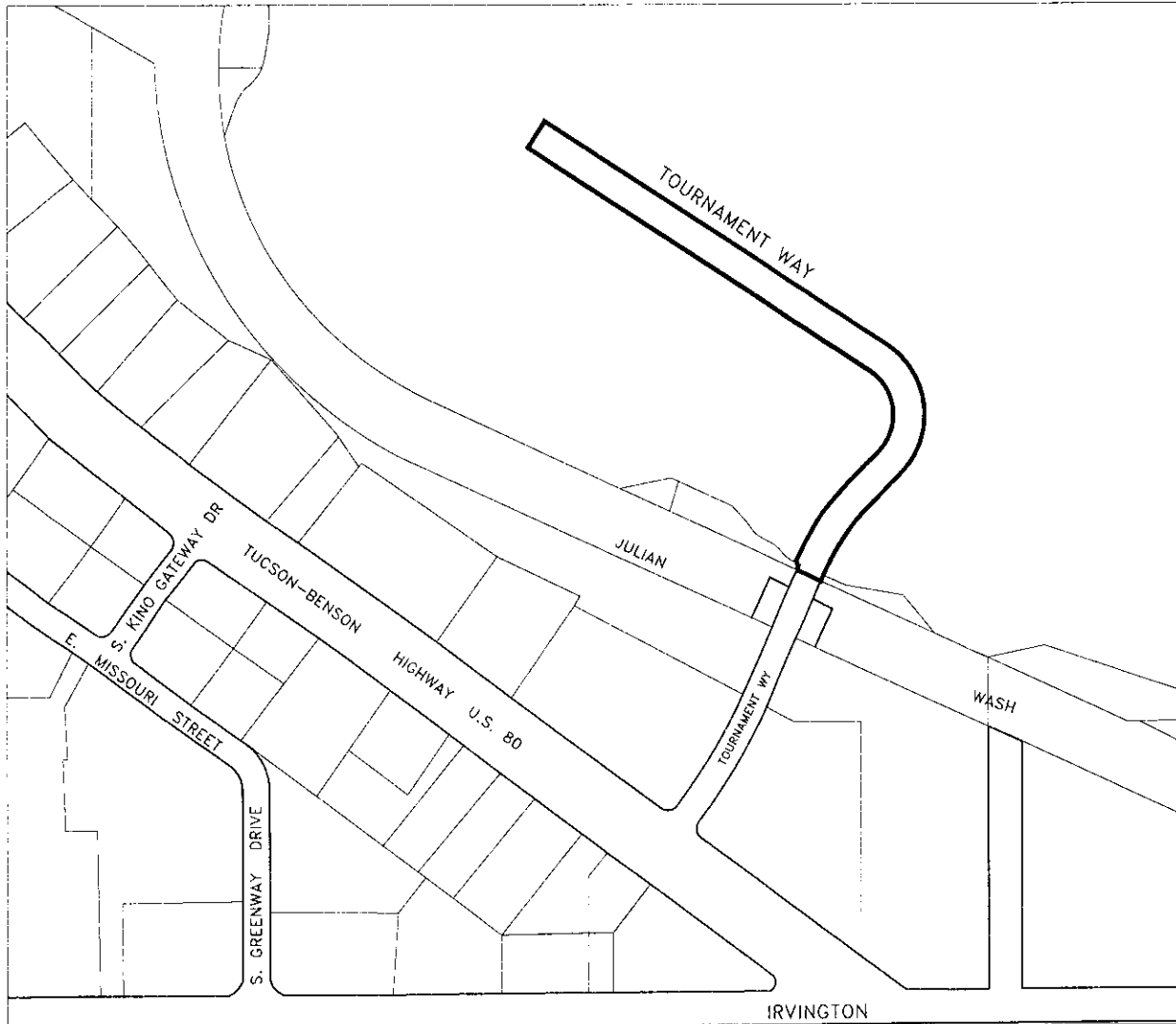

LEGAL DESCRIPTION
TOURNAMENT WAY

A portion of the Southwest One-Quarter of Section 32, Township 14 South, Range 14 East, Gila & Salt River Meridian, Pima County, Arizona, being a portion of Block "B" of Kino Block Plat Abandonment of Irvington Place, (Book 62 of Maps and Plats Page 63), recorded in Sequence 20182640610, in the office of the Pima County Recorder, Arizona, more particularly described as follows:

COMMENCING at the southeast corner of said Southwest One-Quarter of Section 32, a found 2" BCSM in a casting stamped "RLS12214", to which the southwest corner of said southwest quarter a found 2" BCSM in a casting stamped "RLS12214", bears South 89°43'53" West a distance of 2642.44 feet;

THENCE along the south line of said southwest one-quarter South 89°43'53" West a distance of 200.82 feet to the intersection of the centerline of Benson Highway;

THENCE along said centerline North 54°09'10" West a distance of 659.25 feet to the intersection of the centerline of State Avenue as shown on the plat for Kino Business Park recorded in Book 36 of Maps and Plats at Page 62;

THENCE along said centerline for State Avenue North 35°46'20" East a distance of 100.30 feet to the beginning of a tangent curve concave to the northwest having a radius of 1399.77 feet and a central angle of 11°01'48";

THENCE continuing along said centerline and along the arc of said curve to the left a distance of 269.47 feet to a point of tangency;

THENCE continuing along said centerline North 24°44'32" East a distance of 330.34 feet to the south line of said Block "B" and the **POINT OF BEGINNING**;

THENCE along the south line of said Block "B" North 65°11'41" West a distance of 30.00 feet to the beginning of a non-tangent curve concave to the west having a radius of 50.00 feet and a central angle of 16°50'42" and to which a radial line bears South 65°11'41" East;

THENCE continuing along said south line and along the arc of said curve to the left a distance of 14.70 feet to the beginning of a non-tangent curve concave to the northeast having a radius of 80.54 feet and a central angle of 05°36'09" and to which a radial line bears South 18°21'39" West;

THENCE continuing along said south line and the arc of said curve to the right a distance of 7.88 feet to a non-tangent point;

THENCE North $24^{\circ}47'57''$ East a distance of 22.32 feet to the beginning of a tangent curve concave to the southeast having a radius of 540.00 feet and a central angle of $19^{\circ}36'24''$;

THENCE along the arc of said curve to the left a distance of 184.79 feet to a point of tangency;

THENCE North $44^{\circ}24'21''$ East a distance of 105.10 feet to the beginning of a tangent curve concave to the west having a radius of 117.00 feet and a central angle of $101^{\circ}25'22''$;

THENCE along the arc of said curve to the left a distance of 207.11 feet to a point of tangency;

THENCE North $57^{\circ}01'00''$ West a distance of 916.81 feet;

THENCE North $32^{\circ}59'00''$ East a distance of 70.00 feet;

THENCE South $57^{\circ}01'00''$ East a distance of 916.81 feet to the beginning of a tangent curve concave to the west having a radius of 187.00 feet and a central angle of $101^{\circ}25'22''$;

THENCE along the arc of said curve to the right a distance of 331.02 feet to a point of tangency;

THENCE South $44^{\circ}24'21''$ West a distance of 105.10 feet to the beginning of a tangent curve concave to the southeast having a radius of 470.00 feet and a central angle of $19^{\circ}36'24''$;

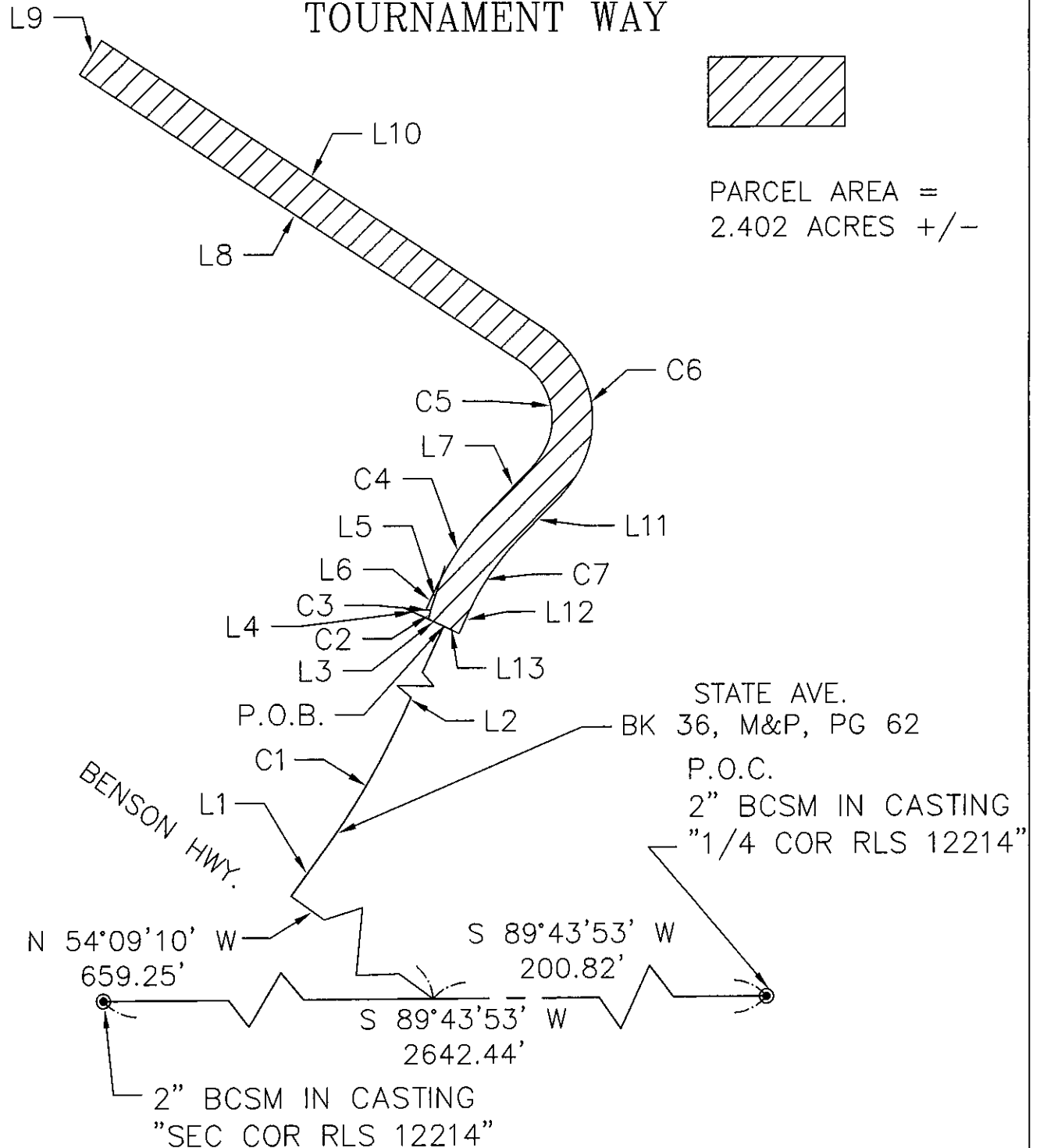
THENCE along the arc of said curve to the left a distance of 160.83 feet to a point of tangency;

THENCE South $24^{\circ}47'57''$ West a distance of 36.32 feet to the south line of said Block "B";

THENCE along said south line North $65^{\circ}44'41''$ West a distance of 30.00 feet to the **POINT OF BEGINNING**.
