

RE: Requested Amendment to Resolution No. 2016-62

Presented for Board consideration is an amendment to Resolution No. 2016-62 which will add authorization for the Clerk of the Board or the County Administrator to provide local governing body approval for applications for joint premises permits in addition to the current authorization to approve special event liquor licenses, temporary extension of premises/patio permit, and wine fair/wine festival permits. Local governing body approval is required by the Arizona Department of Liquor Licenses and Control prior to their issuance of a license/permit.

Application approvals for joint premises permits will be reported to the Board of Supervisors on the Consent Calendar in the same format as special event liquor licenses, temporary extension of premises/patio permits, and wine fair/wine festival permits.

RESOLUTION NO. 2019-_____

The Board of Supervisors of Pima County, Arizona finds:

1. On October 18, 2016, the Board of Supervisors adopted Resolution No. 2016-62, amending Resolution No. 2015-64, authorizing the Clerk of the Board, or, in the Clerk's absence, the County Administrator, to provide local governing body approval for special event liquor license applications, temporary extension of premises/patio permit applications and wine fair/festival applications on behalf of the Board of Supervisors.
2. Effective August 27, 2019, the Arizona Legislature enacted A.R.S. § 4-207.02, which authorizes the Arizona Department of Liquor Licenses and Control to grant joint premises permits to liquor licensees holding the same type of bar, beer and wine bar, restaurant or remote tasting room license.
3. Under A.R.S. § 4-207.02, an applicant for a joint premises permit must submit a copy of the application to the local governing body, which may review the application and provide an advisory recommendation to the Arizona Department of Liquor Licenses and Control.
4. Local governing body advisory recommendations under A.R.S. § 4-207.02 are ministerial actions similar to those actions covered by Resolution 2016-62, and those actions can sometimes be needlessly delayed due to the recommendation process.

NOW, THEREFORE BE IT RESOLVED, that the authorization provided in Resolution No. 2016-62 is hereby amended as follows: the Clerk of the Board, or in the Clerk's absence, the County Administrator, is authorized to provide local governing body approval for special event liquor license applications, temporary extension of premises/patio permit applications, wine fair/festival applications, and joint premises permit applications on behalf of the Board of Supervisors. If, in the opinion of the Clerk or County Administrator, as applicable, approval would not be in the best interests of the community, the application shall be placed on an agenda of the Board of Supervisors for deliberation and final decision. This authorization does not apply to an application for a permanent extension of premises/patio permit.
