

My request is based on the following points:

In October of 2017, the Executive committee of the board of directors of the International Church of the Foursquare Gospel, ICFG, transferred the property located at 125 W. Veterans Blvd. Tucson. AZ to our church: Van Nuys Hispanic Foursquare Church, dba La Iglesia En El Camino, LIEEC.

On May of 2018, I received an email from the interim Administrative Pastor from ICFG (Hispanic District) stating that Months back, in 2017, he received the Affidavit for Organization Tax Exemption form for the property mentioned above. He had misplaced the documents and did not forward it to us on time, and that it was due March 1st. 2018.

On June 20 of 2018, I filled out the Tax Exemption Waiver for the tax year 2018. The same form was approved by the Board of Supervisors on August 20, 2018. It was mailed back to me in September. By the time I received the redemption waiver I completely ignored I had to file it



with the Pima County Assessor's Office before October 1st. I would have appreciated if I had received any type of document with instructions or directions for this next step. On the other hand, for the 2019 approved Redemption Waiver, I did receive a yellow paper titled "NEXT STEP" with the instructions of what and where to submit the redemption waiver with the application. Again, I ignored about the next step after having received the approved redemption waiver for the year 2018.

On June 7 of 2019, I received from the PIMA County Treasurer's Office a "NOTICE OF PAST DUE REAL ESTATE TAXES" for more than \$10,000. At that time, I communicated with Mrs. Kem Krsak who very gently recommend me to send the 2018 Tax Redemption together with the application documents, questionnaire, Financial Report, By Laws, etc. to the PIMA County Assessor's Office. In August 22, 2019 I received an email from the PIMA County Assessor's Office communicating to me that they could not process my 2018 affidavit and Waiver as it is past the deadline of October 1, 2018. Also, they said "their office no longer has the authority to apply a tax exemption for the 2018 tax year " and that I would need to speak to the Board of Supervisors.

In Tuesday 27, 2019 I talked to Mrs. Castañeda from the Board of Supervisors, I explained to her our situation above mentioned, who told me that I could send the Waiver to the Board of Supervisor for review, and that there was no guarantee that I would receive the tax exemption of the year 2018.

I really appreciate the time you would take to review my case and consider all the points I have mentioned above. I also have included to this letter the application, questionnaire, and the other documents you requested.





SECTION ONE: INTRODUCTION

1.1 Scope of the Handbook

This handbook contains policies and practices relevant to the staff members of La Iglesia En El Camino("LIEEC" or "Church"). All staff members are referred to as staff members throughout this Handbook, unless otherwise stated.

The Church has prepared this manual to provide each staff member with an overview of its employment guidelines, policies, and benefits. It is designed to acquaint the staff member with important information about the Church, as well as their privileges and responsibilities. This Handbook is not a contract or a legal document. However, it is important that you read the entire Handbook promptly so that you will have a complete understanding of the material covered. If you have any questions about this Handbook, please discuss them with the Senior Pastors, and the Executive Team. Once, you have read and feel comfortable with the Handbook, please sign the Staff Statement Acknowledgment Form found at the end of this Handbook. This Acknowledgment Form shall be placed in your personnel file.

1.2 Notice of Change

This Handbook merely highlights the Church's policies, practices, and benefits for your personal education and is not a legal document. It is not possible to anticipate every situation that may arise in the workplace or to provide information that answers all possible questions. In addition, circumstances will undoubtedly require changes in the policies, practices, and benefits described in this Handbook from time to time. Accordingly, the Church reserves the right to amend, supplement, or rescind any provisions of this Handbook, other than its employment-at-will provisions, as it deems appropriate in its sole and absolute discretion. As policies and benefits are revised, an email will be sent to all staff at their LIEEC.org email address notifying them about a change having been made to the Handbook. Staff members will be encouraged to review the change and obtain a copy of the Handbook if desired.

1.3 Employment Relationship

The Church hopes that every staff member will find the employment relationship to be satisfying and rewarding. It recognizes, however, that employment relationships are not always mutually satisfactory. To protect both parties' rights, it should be remembered that the employment relationship is terminable atwill, at the option of the staff member or the employer. Thus, a staff member is free to resign at any time, just as the Church is free to terminate employment at any time, with or without cause, or any reason or advance notice. The at-will employment relationship may be modified only in writing, signed by the Senior Pastor of the Church and approved by the Church Council. No manager, supervisor, or other staff member of the Church has any authority to enter into any agreement for employment for any specified period of time or to make any agreement for employment other than at-will.

This staff member Handbook contains our employment policies and practices in effect at the time of publication. All previously issued handbooks and any inconsistent policy statements or memoranda are superseded. All questions regarding the policies outlined in this Handbook should be directed to your supervisor, the Executive team or the Senior Pastor of the Church.

SECTION TWO: GOVERNING POLICIES & PROCEDURES

2.1 Equal Employment Opportunity Policy and Policy Against Discrimination and Harassment

The Church believes in respecting the dignity of every staff member and expects every staff member to show respect for colleagues, clients, customers, and vendors. Respectful, professional conduct furthers the mission of the Church. The Church is committed to providing a work environment free of unlawful discrimination and harassment, including sexual harassment. The Church does not discriminate or allow harassment on the basis of race, color, creed, national or ethnic origin, citizenship, age, sex, gender, marital status, political affiliation, military service, genetic information; (Genetic information includes information about an individual's genetic tests and the genetic tests of an individual's family members, as well as information about the manifestation of a disease or disorder in an individual's family members. i.e. family medical history), medical condition, or against qualified individuals with mental or physical disabilities, or on any other characteristics which are protected by state or federal law and which apply to religious organizations such as the Church. The Church also prohibits unlawful harassment based on any of these characteristics.

All such discrimination and harassment is unlawful. This policy applies to all staff members and prohibits unlawful discrimination and harassment by any staff member of the Church against another staff member, supervisor, client, vendor, independent contractor, Church member or visitor, or any other third party who is doing business with the Church.

Any incident that may be regarded as discrimination or harassment should be reported immediately – either orally or in writing – to the department manager, or Executive Pastors. All complaints of discrimination or harassment will be thoroughly, promptly, and objectively investigated. Confidential information will be disclosed only on a strict, need-to-know basis. The Church will not retaliate against a staff member for filing a complaint or for participating in an investigation and will not tolerate or permit retaliation by management, staff members, or co-workers.

2.2 Sexual Harassment

The Church strictly prohibits any form of unlawful harassment, including sexual harassment, by a staff member, supervisor, manager, agent of Church, Church member, vendor, independent contractor, or others doing business with the Church.

Sexual harassment includes making unwanted sexual advances and requests for sexual favors. It also includes unwelcome conduct, such as conversations regarding sexual activities and other verbal or physical conduct of a sexual nature. Sexually harassing conduct can be by a person of either the same or opposite sex.

Examples of conduct that violates this policy include:

- Unwelcome sexual advances, flirtations, advances, leering, whistling, touching, pinching, assault, blocking normal movement;
- Requests for sexual favors or demands for sexual favors in exchange for favorable treatment;
- Obscene or vulgar gestures, posters, or comments;
- Sexual jokes or comments about a person's body, sexual prowess, or sexual deficiencies;
- Propositions, or suggestive or insulting comments of a sexual nature;
