## CONTRACT AMENDMENT

The parties agree to amend the above-referenced contract as follows:

### 1. Background and Purpose.

1.1. <u>Background</u>. On February 17, 2015, County and Contractor entered into the above referenced agreement to provide legal advice and representation in property tax appeal cases where the Assessor is the plaintiff.

- 2. Maximum Payment Amount. The maximum amount the County will spend under this Contract, as set forth in Article III, is increased by \$50,000.00. County's total payments to Contractor under this contract, including any sales taxes, will not exceed \$200,000.00.
- 3. Israel Boycott Certification. Pursuant to A.R.S. § 35-393.01, if Contractor engages in forprofit activity and has 10 or more employees, and if this Contract has a value of \$100,000.00 or more, Contractor certifies it is not currently engaged in, and agrees for the duration of this Contract to not engage in, a boycott of goods or services from Israel. This certification does not apply to a boycott prohibited by 50 U.S.C. § 4842 or a regulation issued pursuant to 50 U.S.C. § 4842.

The effective date of this Amendment is October 15<sup>th</sup>, 2019.

All other provisions of the Contract not specifically changed by this Amendment remain in effect and are binding upon the parties.
