2019 Paul Coverdell Forensic Science Improvement Grant

***Purpose:**

To clear a backlog of legacy cases at the Office of the Medical Examiner, and employ and train a Forensic Anthropologist Postdoctoral Fellow.

***Procurement Method:**

This agreement is a non-procurement agreement and not subject to procurement rules.

***Program Goals/Predicted Outcomes:**

Funding awarded to the Pima County Office of the Medical Examiner will support a post-doctoral forensic anthropologist fellow, and provide for costs to extract DNA and aid in the identification of 54 legacy cases which have never undergone DNA analysis. The project will exhume and re-examine these legacy cases and provide practical experience for a Forensic Anthropologist Postdoctoral Fellow.

***Public Benefit:**

An award from the DOJ provides a chance to identify these individuals, providing closure for loved ones and potentially aiding with homicide investigations so justice may be served.

***Metrics Available to Measure Performance:**

Program performance under this award is measured by the percent reduction in the number of backlogged forensic cases and the number of forensic science or medical examiner personnel who completed training or educational opportunities with Coverdell funds.




This funding will support a Forensic Anthropologist Postdoctoral Fellow position, to increase the Office of the Medical Examiner's capacity to analyze cases and provide hands-on training in a highly specialized field. Congratulations on your recent award! 

1. Requirements of the award; remedies for non-compliance or for materially false statements

24. Restrictions on "lobbying"

32. Generally Accepted Laboratory Practices

The recipient shall ensure that any forensic laboratory, forensic laboratory system, medical examiner's office, or coroner's office that will receive any portion of the award uses generally accepted laboratory practices and procedures as established by accrediting organizations or appropriate certifying bodies.

External Investigations

The recipient shall ensure that requirements associated with 34 U.S.C. section 10562(4) (which relate to processes in place to conduct independent external investigations into allegations of serious negligence or misconduct by employees or contractors) are satisfied with respect to any forensic laboratory system, medical examiner's office, coroner's office, law enforcement storage facility, or medical facility in the State that will receive a portion of the grant amount.

15. SUMMARY DESCRIPTION OF PROJECT (See instruction on reverse)

The Pima County Office of the Medical Examiner (PCOME) in Tucson, Arizona, serves as the investigatory body for reportable deaths within Pima County, as well as neighboring Santa Cruz and Cochise counties. The PCOME provides contracted medical examiner services for agencies throughout the state of Arizona. Internal records indicate there were 131 individuals examined before the year 2000 who remain unidentified in Pima County. Of these, 54 cases are deemed legacy cases that have never undergone DNA analysis. The proposed project will exhume and reexamine this legacy casework and provide practical experience for a Forensic Anthropology Postdoctoral Fellow responsible for managing this project. The project will focus on cases with from 1964 to 1999 with remains that were buried prior to the retention of DNA samples. This funding request would support a Forensic Anthropology Postdoctoral Fellowship position, and cover the cost of exhuming 32 coffins containing 54 unidentified decedents for updated forensic examinations using modern methods, including DNA sample collection. DNA-based matches are the most likely method of identification for all of these individuals due to limited casefiles and the passage of time. For those whose death was ruled a homicide, this project may aid in the possible apprehension of the perpetrator(s) if the victims are identified. This funding would provide the best chance at

identifying these individuals, and returning their remains to their loved ones with potential justice served.
