Title: Temporary Road Closure Resolution

Introduction/Background:

Perimeter Bicycling Association of America has requested the temporary closure of portions of Aviation Parkway, Valencia Road, Mary Ann Cleveland Way, Colossal Cave Road, Pistol Hill Road, Old Spanish Trail, Freeman Road, Speedway Boulevard, Houghton Road, Snyder Road, Bear Canyon Road, Palisade Drive, Rockcliff Road, Tourmaline Drive, Bauxite Way, Cheyenne Trail, Sandstone Drive, Sabino Canyon Road, Sunrise Drive, Skyline Drive, Ina Road, Yucca Via, La Canada Drive, Magee Road, Cortaro Farms Road, Thornydale Road, Twin Peaks Road, Silverbell Road and Sunset Road for the El Tour De Tucson event on Saturday, November 23, 2019 from 5:00 A.M. to 4:00 P.M.

Discussion:

As a result of the Special Event Permit Application review, road closures, including potential detour route, if needed due to inclement weather or other circumstances are recommended to facilitate this event.

Conclusion:

Pima County Transportation recommends the temporary closure of portions of these roadways to enhance the safety of the El Tour De Tucson event by reducing potential vehicular conflicts.

The Board of Supervisors of Pima County, Arizona finds:
