Title: Temporary Road Closure Resolution

Introduction/Background:

Events for Everyone, LLC has requested the temporary closure of portions of Kinney Road, portions of Mc Cain Loop, and portions of Mile Wide Road for the Veterans Day Half Marathon and 5K event on Sunday, November 10, 2019 from 4:30 A.M. to 11:45 A.M.

Discussion:

As a result of the request and Special Event Permit Application review, Pima County Department of Transportation (PCDOT) recommends the temporary closure of portions of Kinney Road, portions of Mc Cain Loop, and portions of Mile Wide Road to facilitate the event.

Conclusion:

PCDOT recommends the temporary closure of portions of Kinney Road, portions of Mc Cain Loop, and portions of Mile Wide Road to enhance the safety of the Veterans Day Half Marathon and 5K event by reducing potential vehicular conflicts.

Recommendation:

PCDOT recommends approval of this resolution to temporarily close portions of Kinney Road from Hal Gras Road to Mile Wide Road, portions of Mc Cain Loop from 600 north Kinney Road to 2350 north Kinney Road and portions of Mile Wide Road from Kinney Road to Sandario Road on Sunday, November 10, 2019 from 4:30 A.M. to 11:45 A.M.

Events for Everyone, LLC has requested the temporary closure of portions of Kinney Road from Hal Gras Road to Mile Wide Road, portions of Mc Cain Loop from 600 north Kinney Road to 2350 north Kinney Road and portions of Mile Wide Road from Kinney Road to Sandario Road from 4:30 A.M. to 11:45 A.M. to facilitate this event.
- 3. The Pima County Board of Supervisors has determined that it will be necessary to permit the temporary closure of portions of Kinney Road, portions of Mc Cain Loop and portions of Mile Wide Road to support this event.
