Amendment to the Avra Valley Expansion Credit Agreement

**\*Purpose:**

This amendment to the Connection Fee Credit Agreement (now referred to as Avra Valley Expansion Credit Agreement) with Trust Number 30,226 for \$439,145.87 allows a five (5) year extension of their contract that expires on 02/08/2020.

Like other residential housing developers in the Avra Valley area, the largest impact to project development over the past ten (10) years was the housing market down-turn. With a recovered market, this developer is again working through the process to bring their housing project to completion. This development's water supply Camino Verde Village (Trust #30,226) was impacted by the 2010 City of Tucson service area change and is currently in the process of establishing a wheeling agreement with Tucson Water and Metropolitan Water to serve the development.

**\*Procurement Method:**

This is a non-Procurement contract and not subject to Procurement rules.

**\*Program Goals/Predicted Outcomes:**

This extension of the Avra Valley Expansion Credit Agreement allows the developer five (5) additional years to recoup their funds expended in the upgrade of the Avra Valley Water Reclamation Facility and if additional time is needed to expend the Credits, the Pima County Director of Procurement may sign for one (1) additional five (5) year term.

Assisting the continued economic development in the southwest area.

**AGREEMENT AMENDMENT**

The parties agree to amend the above-referenced agreement (the "Agreement") as follows:

**1. Background and Purpose.**

1.1. Background. County and Applicant entered into the Agreement (contract no. 14-03-F-142716-0210), effective February 9, 2010, wherein County issued wastewater utility fee (formerly "connection fee") credits in the amount of \$439,145.87 to Applicant to compensate Applicant for its expenditure of that amount toward expansion of County's Avra Valley wastewater reclamation facility. The term of the Agreement was ten (10) years.

1.2. Due to economic conditions, Applicant was unable to proceed with its planned property development within the term of the Agreement and therefore was unable to timely use the credits authorized by the Agreement.

1.3. Applicant requested, and County agrees to, an extension of the Agreement Term for an additional five (5) year period.

**2. Term.** The Agreement terminates on February 8, 2025. The Agreement may, at County's sole discretion, be extended for one (1) additional five (5) year period. The Pima County Procurement Director is hereby authorized to execute such a term extension agreement on behalf of the County.

**3. Substitution.** The term "Wastewater Utility Fee" is substituted for the term "Connection Fee" throughout the Agreement.

**4. Change in Contract Number.** The contract number is changed from 14-03-F-142716-0210 to CTN-WW-20-079.

**5. Israel Boycott Certification.** Pursuant to A.R.S. § 35-393.01, if Applicant engages in for-profit activity and has 10 or more employees, and if this Agreement has a value of \$100,000.00 or more, Applicant certifies it is not currently engaged in, and agrees for the

duration of this Agreement to not engage in, a boycott of goods or services from Israel. This certification does not apply to a boycott prohibited by 50 U.S.C. § 4842 or a regulation issued pursuant to 50 U.S.C. § 4842.

All other provisions of the Agreement not specifically changed by this Amendment remain in effect and are binding upon the parties.




